

**Minutes of the Pre-Bid Meeting held on 27<sup>th</sup> September 2023 in WBMIFMP Conference Hall, Ninth Floor, Jalasampad Bhavan, Salt Lake City, Kolkata – 700 091 in connection with the work: -**
