Name of the work:

Carrying out bank to bank cross sections & long sections survey work on River Brahmani, Haria, Ashuni, Sholkhana Khari for a approx. length of 78.500 KM consisting of survey & preparation of maps, plan, cross section & long section in requisite scales to supply them in both soft and hard copies alongwith BM carry & connection at different point in the District- Malda & South Dinajpur.

Encrypted electronic NIQ are hereby invited by the **Sub Divisional Officer**, **Malda Investigation Sub Division**, **Green Park**, **Malda under Malda Irrigation Division**, **Irrigation & Waterways Directorate** on behalf of the Governor of the State of West Bengal through a single stage two part e-NIQ System; (Part I: Technocommercial bid and Part II: Financial bid) for the above mentioned work from eligible firms/bidders having specified Pre-Qualification (eligibility) credential for execution of works of similar nature and desired financial capabilities.

Intending firms/bidder desirous of participating in this e-NIQ are required to login to the Government of West Bengal e-Procurement website having URL <u>https://wbtenders.gov.in</u> and locate the instant EOI by typing **WBIW/SDO/MInvSD/eNIQ02/23-24** in the search engine provided therein, or by logging-in using their assigned User ID and password. They may also visit the official website of the Irrigation & Waterways Department, Government of West Bengal <u>www.wbiwd.gov.in</u> to locate the same e-NIQ by scrolling the "e-Procurement" link.

Firms/bidder willing to take part in the e-NIQ are required to obtain a valid Digital Signature- Certificate (DSC) from any of the authorized 'Certifying Authorities' (CA) under Controller of Certifying Authorities (CCA), Department of Electronics & Information Technology (DEIT), Govt. of India. (viz. NIC, n-Code Solution, Safe scrypt, e-Mudhra Consumer Services Ltd, TCS, MTNL, IDRBT) or as notified by the CA /Finance Department, GoWB from time to time. DSC is given as a USB e-Token. After obtaining the Class 2 or Class 3 Digital Signature Certificate (DSC) from any of the above CA, they are required to register the fact of possessing the DSC through the registration system available in the above mentioned websites. A list of such licensed CAs' are also available in the CCA website <u>cca.gov.in</u>. #### Download and Submission of e-NIQ :

Intending firms/bidder are required to download the e-NIQ documents directly from either of the websites stated above. **This is the <u>only mode</u> for submission of the e-NIQ**. The interested bidders eligible for the e-NIQ are required to submit their bids through the e-Procurement System using their valid DSC e-Token with assigned PIN using login ID and password. Details of e-filing procedure for participating in e-Tenders under State Government have also been explained in the 'Bidders' Manual', available in the Departmental website <u>www.wbiwd.gov.in</u>.

#### Last date & time of submission of bid electronically, is on 11.12.2023 till 13:00 Hours IST

The applicant bidders/firms are advised to carefully read all the 'Terms & Conditions' contained in this e-Notice Inviting e-NIQ. He/she should particularly go through the minimum desired Pre-qualification (PQ) works credential & financial eligibility criteria and satisfy himself/herself of all the mandatory eligibility requirements. Bidders desirous of participating in the e-NIQ should submit bids only if they fulfill the minimum PQ eligibility



criteria and are in possession of all the required PQ Credential documents "in original" as these may be summoned by the electronic NIQ inviting authority & accepting authority for verification purposes.

## 1. Terms & Conditions:

- 1.1. Electronic notice inviting quotation for obtaining competitive market price is being invited by the **Sub-Divisional Officer, Malda Investigation Sub-Division, Green Park, Malda** in connection with determination of estimated cost of the above mentioned work.
- 1.2. The intending firms/bidders should submit their most competitive quotes as per current market price in the financial proposal.
- 1.3. Quoted rates should be inclusive of all taxes (GST) and duties all complete.
- 1.4. Acceptance of lowest quote submitted by the intending bidders entirely rests upon the Superintending Engineer, North Circle-I, Green Park, Malda. The authority reserves the right to accept or reject any or all e-NIQs without assigning any reason thereof.
- **1.5.** As the notice inviting e-NIQ is made for estimation purpose, work order may be issued only after getting financial approval from the competent authority and no payment whatsoever should be borne by I & W department for submission of e-NIQ.
- 1.6. Agreement shall be made on the West Bengal Form No- 2911/ 2911(i)/2911(ii) before issuance of the work order.

### 2. Scope of the Work:

### Survey work is comprising of the following.

- 2.1. Long section, Cross-section (@100m c/c or less where necessary of the rivers/khari as appropriate with distinctly legible marking of G.L. /HFL /LWL etc. with appropriate R.L. Cross Sections must be extended at least 30m away from the existing river bank line, showing the location of Berm/Pond/depressions/road etc. as the case may be. Few of the cross section should be extended upto 500 m from the center line in both way. These additional cross-sections should be taken @ 500 m c/c along the river.
- 2.2. Colour Google map showing all the river & notable land mark in a single sheet.
- 2.3. Separate Plan for each of the rivers/Khari showing nearby villages with due Legends, structures etc preferably coloured. Structures, land marks should be geo-tagged.
- 2.4. Benchmark connection for different point from permanent bench mark (GTS) as per direction of EIC
- 2.5. Submission of survey report containing cross-section, long section, google map, plan & topo sheet as applicable in 5 nos. hard copy and soft copy in excel & auto-cad showing GTS RL.
- 2.6. Raw data (in specified format) of the survey work shall have to be submitted as & when demanded by the EIC.
- 2.7. Time allowed for completion of the survey work is 30 calendar days.

A brief details of the rivers/khari is given in the 'Annexure 1'

(Note: - The rate should be quoted by considering the cost of flying of GTS Bench Mark from nearest available locations upto working location and all incidental charges like carriage of instruments,

engagement of manpower, boat and machineries etc required to complete the work in all respect.) 3. <u>Technical Compliance:</u>

The bidder is qualified only when he is the actual service provider and meets the required norms as specified below and all original evidences or valid supporting documents to be produced in due course of time as & when asked by the Quotation Inviting Authority/ Quotation Accepting Authority:-

1.	Firms should have the following survey equipment/instruments to complete the survey work :-
1.a	Differential GPS/RTK for land survey.



1.b ADCP - Acoustic Doppler Current Profilers with integrated GPS software for hydrographic survey of the rivers/khari.

The firm should have completed one (01) similar nature work in the last five (5) in any Central/State Govt. Sector having minimum awarded value Rs. 10.00 lakh.

### **Brief Description of the River**

**The Haria River:** The Punarbhaba throws a spill channel in south-west direction at Village Battali, Mouza- Khutadaha in the Bamongola Block. The spill named, the Haria, travels a distance of about 21 kms and meets the Punarbhaba again in Bangladesh. The river flows through Jagdala & Chandpur Gram Panchayat within the block.

**The river Brahmani** originates from the low lying area of Gangarampur in South Dinajpur district. The river flows almost toward south direction as far as South Dinajpur District. From the border of South Dinajpur it takes sharp bend to west and flows along a winding course in the western direction, until it out falls into the river Tangon at Mouza Baherpur, Block-Bamongola, Dist- Malda. It flows through the moribund Tal areas of Gangarampur & Tapan Block within South Dinajpur District for more or less 23 km and the Barind track of Bamongola Block within Malda district for length of more or less 12 km. The river flows 24 km toward south and 6 km toward west direction. The river flows through Madnabati Gram Panchayat in Bamongola Block.

**The Channel Ashuni** originate as spill channel from the river Brahmani at Bholabasna, G.P.-Madnabati. The channel flows toward south direction through the low lying area of Madnabati, Ganespur-Maheshpur & Chandpur Gram Panchayat in the Bamongola Block. Finally it meets river Haria at Chotopathari after travelling 14.400 km.

The Sholkhana Khari, one of the other notable natural stream, originates from low lying area of Gobindapur-Maheshpur Gram Panchayat of Bamongola Block. It travels 8.000 km through Bamongola & Gobindapur-Maheshpur Gram Panchayat of Bamongola Block and ultimately outfalls at river Tangon at Bamongola GP.
