All documents uploaded by the Tender Inviting Authority forms an integral part of the works contract/Agreement. Contractors/bidders are required to upload the entire tender documents along with all other relevant PQ credential documents as asked for in the e-NIT, electronically, through the above portal within the stipulate date and time as notified in the e-NIT. Tenders are to be submitted in two parts/folders at the same time for each work, one being Technical Proposal' and the other Financial Proposal'. The contractor/bidder should carefully go through all the Documents of thee-tender and upload the scanned copies of his/her/their original documents in Portable Document Format' (PDF) files in the designated links in the web portal as their' Technical Bid'. He/she needs to fillup the financial offer/bid price/ rates in percentage above or below or At-Par' in the downloaded BOQ of the work in the designated cell in 'Excel sheet only' and upload the same in the designated link of the portal as their' Financial Bid'. Documents uploaded are virus scanned and required to be digitally signed using their Digital Signature Certificates' (DSC). Contractors/bidders should especially take note of all the Addenda or Corrigenda notices related to the e-Tender and upload all of these documents forming a part of their e-bid as tender document.
