

 - Supplying & Laying in the specified pattern of Interlocking Concrete Block Pavements (ICBP) with concrete blocks (with Concrete grade as specified as per Table-I of IS 15658 : 2006) manufactured from BIS licensee manufacturer
 - All types of Moorum road works & WBM Sub Base
- Baseline environmental parameters needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
