Bids are to be submitted electronically in the on-line mode through the e-Procurement portal www.wbtenders.gov.in. All documents uploaded by the Tender Inviting Authority forms an integral part of the works contract/Agreement. Contractors/bidders are required to upload the entire tender documents along with all other relevant PQ credential documents as asked for in the e-NIT, electronically, through the above portal within the stipulate date and timeas notified in the e-NIT. Tenders are to be submitted in two parts/folders at the same time for each work, one being TechnicalProposal' and the other Financial Proposal'. The contractor/bidder should carefully go through all the Documents of thee-tender and upload the scanned copies of his/her/their original documents in PortableDocumentFormat' (PDF) files in the designated links in the webportal as their' Technical Bid'.
