Name of work: Execution of Penetration resistance and Ultrasonic Pulse Velocity Test at Keyatala Sluice cum regulator bridge at Ch.410.00 over Suryapur Inner Channel in P.S. & Block – Baruipur , Dist. South 24 Parganas".

1.The intending quotationers having valid licenses, PT & IT, PAN, GST registration etc. should possess adequate experience in the field of Conducting Penetration resistance Test and Ultrasonic Pulse Velocity Test in existing sluice cum Bridge structure.

2. Prior to furnishing the detailed report, the lowest quotationer should get well acquainted with his assignment in detail discussions with the Engineer-in-charge or his authorized representative to avoid submission of any incomplete report which is liable to be rejected. The Engineer-in-charge reserves the right in this regard to reject any/all incomplete [in terms of requirement of the department] report without assigning any reason thereof. The lowest quotationer is liable to rectify any error/omission detected by the department at his own cost. No claim whatsoever in this regard from the quotationer will be entertained. The documents to be supplied in detailed report in 6(six) nos. of Hard copies and 2(two) nos soft copies. The decision of the Engineer-in-charge is final and binding. In this regard.

Scope of Work:

1. Conducting Penetration resistance Test including mobilization charges and submission of detailed report in 6(six) nos. of Hard copies and 2(two) nos soft copies. Length of Bridge 21.534 m and width 7 m (without footpath)
2. Conducting Ultrasonic Pulse Velocity Test including mobilization charges and submission of detailed report in 6(six) nos. of Hard copy and 2(two) nos soft copies. Length of Bridge 21.534 m and width 7 m (without footpath)

The bridge location to be tested should be inspected and made necessary reconnaissance of by the lowest quotationer with the departmental representative. Any part area/patch of the bridge area relevant to the whole test, if not reflected inadvertently, is to be tested by the quotationer at his own cost.

The Penetration resistance Test and Ultrasonic Pulse Velocity Test work including submission of requisite reports both in hard and soft copies separately for each item mentioned in the scope of the work of N.I.Q. is to be executed within 20 (twenty) days from the date of issue of the work-order. Finalization of drawing as stated above will rest upon the discretion of the Engineer-in-charge, No claim what so ever in this regard will be entertained.

The quotation is to be submitted in the prescribed format including GST and other necessary Taxes. Any incomplete/illegible quotation is liable to be rejected. For evaluation of lowest quotationer the total amount will be considered.
