## **Terms & conditions of NIQ No WBIW/EE/KCD-IV/NIQ-01/2024-25.**

- 1) The car will be hired on daily rated monthly basis whose payment will be made by 'e-billing system' in favour of the owner on the basis of bill submitted at the end of every month duly checked and passed by the Executive Engineer, Kangsabati Canals Division No-IV. Normally number of days of hire charge bill will be as per requirement of Superintending Engineer, Kangsabati Circle-II.
- 2) The vehicle must have contract carriage permit for whole West Bengal
- 3) The vehicle should be in good condition as regards to body and engine with necessary accessories and to be provided with an **efficient** driver having valid vehicle driving license. The wages and allowance of the driver will have to be paid by the owner of the vehicle including overtime allowance if necessary. The vehicle should be Motor Cab/Maxy Cab/ Luxury Cab (diesel Engine) purchased on or after 2009.
- 4) Normal hours of duty will depend on the officer's requirement. Generally the vehicle will run on all working days. But may be extended on emergent duty on other day if required during irrigation period or any other reasons.
- 5) The vehicle will have to be supplied with its driver who will be responsible to report for duty with the vehicle at the prefixed station within stipulated time unless otherwise specified. The driver has to be capability of well drive even in night. The nature of driver should be good in behave and manners.
- 6) Though the vehicle will be hired on monthly basis, payment will not be made for the day if the car is on break down or any other mechanical fault/or due to the driver. In the event of failure of the driver to attend duty as per prefixed programmed and time, recovery at double the rate of hire charges for that day/days would be effected.
- 7) Owner of the vehicle will be responsible for all types of repair and maintenance of the vehicle including periodical servicing and no payment will be made for that period, if not replaced by another car of good condition.
- 8) Diesel and Mobil will be supplied by the Department/ supplier from a selected Filling Station. Fuel consumption will be 12 (twelve) km/Litre of diesel and Mobil oil consumption @ 500 km/Litre. No other lubricant will be allowed by the office.
- 9) The owner of the vehicle, whose quotation will be accepted, will have to execute a formal agreement with the Executive Engineer, Kangsabati Canals Division No-IV.in 2911 Form.
- 10) If the agreement is terminated without notice of one month by the supplier, then he will have to arrange a separate car for emergency duties.
- 11) The accepting authority/ Superintending Engineer, Kangsabati Circle-II, Abas, Midnapur reserves the right to cancel either the lowest or any other quotation without assigning any reason what so ever. The owner of the vehicle will have to report for testing the car within 3 (three) days of receipt of letter of acceptance.

- 12) The authority will not have any liability arising out of any accident in running the car whether or not the same was caused due to negligence etc. of the driver. The authority will not be liable to pay any damage to the owner, driver or, any third party arising out of use of the car.
- 13) Day to day Log Book will have to be maintained and signed by the driver and the officer using the vehicle.
- 14) The owner will be required to produce the bill in triplicate for processing of payment through the Vadutala Section under Kangsabati Canal Sub-Division No-XII after the end of each calendar month.
- 15) The authority may terminate the agreement at any time without assigning any reasons what so ever for which no compensation will be paid.
- 16) Periodic maintenance , regular servicing ,cleaning of vehicle is to be done by owner is its own cost.
- 17) Driver with capricious, erratic, arrogant attitude or alcohol addiction should be replaced immediately, otherwise the contract will be terminated at any time with imposition of penalty as per Clause 3 of WBF No.2911.
- 18) Usual recovery as per rule will be made from the running bills on account of Income Tax as applicable.
- 19) No quotation paper will be supplied by Post.
- 20) No quotation paper will be issued after expiry of date and time mentioned in the notice.
