

TERMS AND CONDITIONS:

1. Rates should be quoted in figures and words as per items of works in the schedule attached with the quotation. Corrections, if any, should be attested under dated initial of the quotationer.
2. Quotations standing lowest will be considered provided that the total value of the works stands lowest. Item wise work will not be considered for fixing the lowest quotation.
3. The inviting authority of the reserves the right to accept any quotation and reject any or all the quotations received without assigning any reason thereof.
4. The rate accepted by the accepting authority will be valid for at least 120 days from the date of submitting the quotation and in no case rate will be enhanced owing to any increase in market price, if he fails to complete the work within the schedule date and time.
5. Rates quoted should be inclusive of all Taxes, carriage, installation, testing and submission of reports, GST etc. complete inclusive of all charges.
6. Time allowed for the work is 15 (Fifteen) days from the date of issue of the work order.
7. The successful quotationer / agency shall have to deposit an amount @ 2.00% of the total quoted amount as earnest money in the form of Bank Draft / Demand Pay in favour of the Engineer in-charge (i.e. Executive Engineer, Teesta Barrage Electrical Division) at the time of executing Formal Agreement in W.B.F. No. 2911 within 15 (Fifteen) days from the date of issue of the accepting letter which will be refunded after successful completion of the contract or termination of the contract whichever is earlier, if the situation so demands in the exigency of the Public Service.

9. Only firms having past Experience and qualification in the field need submit quotation.


