

- Construction methodology may be submitted in detail incorporating following components:
 - Construction Methodology for Mundeswari Irrigation Sub-Division Office.
 - Supplying and Laying in the specified pattern of Interlocking Concrete block Pavements (ICBP) with concrete blocks (with Concrete grade as specified as per Table 1 of IS 15658: 2006) manufactured from BIS licensee manufacturer.
- Baseline environmental parameters needs to be taken prior to commencement of works.
- Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- All duration of work mentioned in method statement should be supported in MS Project.
- PER-1 & PER-2 may be freshly submitted incorporating the criteria mentioned in “Key Personnel” of Section III of bid document.
