

- 1) A brief mention in line with GCC 15.3 under PCC should be made at the beginning of the Construction Methodology.
- 2) Construction methodology may be submitted in details incorporating following components:
 - Construction Method
 - Drawing & Document Submission
 - Submission of Documents
 - Schedule of work and Progress Reports
 - Operation Manual and As-Built Drawings
 - Spare Parts and Tools
 - Data and facilities supplied by the employer under the contract
 - Performance requirements
- 3) Quality control procedures and assurance plans given in the bid to be submitted in details incorporating following components.
 - Law, regulations, codes and standards
 - Inspection and Testing Requirements
 - Test categories of materials
 - Shop/ Factory Tests
 - Packing, Handling and Transportation
 - Site Inspection and Tests
 - Installation Tests, Operational Test (OT), Final Acceptance
- 4) Quality Assurance Programme prepared as per guidelines and contents provided in "A-1.2, SECTION A – GENERAL SPECIFICATION under Section VII- Work's Requirement".
- 5) Baseline Environment, Social, Health and Safety management strategies and implementation plan under Appendix-II/12 needs to be elaborated in details for taking up during execution.
- 6) Site Mobilization Plan needs to be submitted in line with Construction Schedule.
- 7) All duration of work mentioned in method statements should be supported in MS Project.
- 8) PER-1 & PER-2 may be freshly submitted incorporating the criteria mentioned in "Key Personnel" of section III of bid documents".
