# SPECIAL TERMS AND CONDITION RELATES WITH THE WORK

2.17 Uptime Calculation & Penalty:

The Actual Uptime on fiber Link to be calculated in respective month and will be measured against total uptime hours 99.5%. If the downtime exceeds the total uptime hours following penalty in % will be applicable:

In such case the Actual Uptime can be calculated as follows: Total hours in the month =  $31 \times 24 = 720$  Actual uptime Hours = 720 - 5 = 715 Actual uptime % =  $(715/720) \times 100 \approx 99\%$ .

#### 2.18 Service Level Agreement :

This SLA describes the Service Levels applicable. Non achievement of a Service Level may attract penalties, as set out in this SLA. The bidder shall sign SLA with the Irrigation & Waterways Department, Govt. of West Bengal incorporating following parameters:
