6. All goods supplied will be subject to our approval and is liable to rejection if found below specification and such rejection will be made at the cost and risk of the Quotationer for which no claim will be entertained.
7. Only goods of standard and good quality will be accepted, inferior quality is not acceptable decision taken by the consignee in respect of the quality will be final.
8. OEM authorization certificate must be submitted along with offer in case of authorized dealers, failing which his Quotation will be rejected.
