- b. or, Evaluation Committee constituted by the Department from time to time.
- iii. Consolidated Debarment List: A list prepared by the Departmental Debarment Committee/Chief Engineer containingthelist of bidders debarred by the Irrigation&Waterways Department,Government of West Bengal. The list would be displayed prominently in the designated link in website of the Department clearly stating the period of suspension/debarment.
- iv. Contract implementation: A process of undertaking a project in accordance with the contract /Agreement documents.
- v. **Debarment:** Anadministrative penalty,in addition to the contract/Agreement provisions, disqualifying abidderfrom participating in any procurement process under Irrigation & Waterways Department, Government of West Bengalfor a given period.
- vi. Debarred Bidder: A Bidder who was disqualified by the competent authority of the Irrigation & Waterways Department, Government of West Bengal.

- **x. Procurement:** It is the act of buying goods, services or works from an external source. It is favourable the goods, services or works are appropriate and that they are procured at the best possible cost to meet the needs of the acquirer in terms of quality and quantity, time and location.
- **xi. Procuring Entity/Authority:** The officer authorised by the Irrigation & Waterways Department, Government ofWest Bengal for procurement.
- **xii. Suspension:** Temporary disqualification of a bidder from participating in the procurement process of Irrigation & Waterways Department for a period of 6 (six) months when an offence is made against a bidder.

- vi. Refusaltoacceptanawardafterissuanceof'LetterofAcceptance'orenterintocontractwiththeGovernment without justifiable cause.
- vii. Refusalorfailuretoposttherequiredperformancesecurity/earnestmoneywithintheprescribedtimewithout justifiable cause.
- viii. Subcontractingofthecontractoranypartthereof without prior written approval of the procuring entity.
- ix. Failure solely due to fault or negligence of the Contractor, to mobilize and start work within the specified period as mentionedin the 'Letter of Acceptance' / 'Letter of Acceptance cum work Order' / 'WorkOrder' / 'Notice of Process' /'AwardofContract'etc.ultimatelyresultinginrescindmentofcontract.
- x. Failure tofullyandfaithfully comply with the contractual obligationswithoutvalidcause, orfailure comply with any written lawful instruction of the procuring entity or his representative(s) pursuant to the implementation of the contract, ultimately resulting in rescindment of contract.
- xi. For the procurement of goods, unsatisfactory progress in the delivery of the goods by the manufacturer, supplier or distributor arising from his fault or negligence and / or unsatisfactory or inferior quality of goods, vis a via as laid down in the contract.

In case, the review only seeks the eligibility of the applicant himself, views of the Tender Evaluation Committee (TEC) would be communicated in writing to that bidder within next two (2) working days. If the bidder is not satisfied with the clarification of the TEC, he/she may appeal to the concerned Chief Engineer within 24hours of receipt of communication from the TEC. The concerned Chief Engineer will dispose such complaints jointly, in associated with at least another available ChiefEngineer withinnext 2 working days. #### Proceduretobefollowedfor finalacceptanceoftender&Awardof Contract

- i. The lowest (L1) financial bid for all works tenders is accepted as a rule. If for any reason the lowest (L1) bid is not accepted, reference is to be made to the appropriate Government for orders as to which of the contractor/bidder the work should be awarded.
- ii. - 2) DutyHours: Security Guards for each category duty hours will be 8hours in each shift.
- a) Incase shortage of Guards due to sick leave or other reason, alternative arrangement for replacement of guard willhave to be made to avoid any kinds of breakage in the duty. No objection shallbe raised by the agency for this reason.
- 3) Guards: The force will engaged personal from Ex-Military, B.S.F., C.R.P.F, C.I.S.F. ordependents of the such persons being civil person and is trained for this purpose.
- 4) Calendar of month: One month will be reckoned from 1st of calendar month to Last of the same month.
- 5) Dress:Uniform and other articles relating to the uniform will be supplied by the agency. No allowance for uniform or damage will be paid to anybody by the concerned authority.
- **6) Duty Articles:** Torch light with cell and others shall be supplied by the Agency as per requirement in consultation with the said security guard.
- **7)** ChangeofGuards:a)The guards will have to replace incase of any complaint/allegation lodged by the concerned authority in writing to the agency.
- a) No claim will be submitted for their permanent service by the agency. The Department shall not be responsible if any liabilities arise in this regards.

- **9) DeathorInjury:** The Department shall not be responsible to compensate or otherwise liable in the manner whatsoever for any injury and/ or death of any guards of the said security force while on duty.
- **10) Handing/TakingOver:**a)The force willtakeoverwholeresponsibilityofallmaterialshandedovertothemwithalist and remain liable for any theft or loss except damage of materials.

- b)Anyverbalinstructionoranyslipsignedbeyondtherankofsectionofficerwillnotbe treated as a Gate pass. Without propergat pass guards willnotbe allowed any vehicles togoin or out. Henceguards will not be responsible for any damage to the vehicles for want to proper gate pass.
- **12) Theft/Fire:**a)Incaseoffirebreaksoutinthepremisespreliminaryactionforits Extinguishmentbylocalarrangement or by informing Fire Bridge /Police Stationwillbe madeby theguards onduty andreportimmediately to the department.
- b) In caseoftheft or any attempt to theft of materials the responsibility of these curity to lodge FIR to the local Police Station after spot verification and also report to concerned Authority.
