NOTICE INVITING TENDER NO. WBIW/AE-I/PID/NIT-01/2024 - 25

- 1. Separate sealed Tenders in printed form are invited by the Assistant Engineer-I, Purulia Irrigation Division on behalf of the Governor of West Bengal, for the works as per list attached herewith, from bonafide reliable and resourceful Contractors having sufficient experience in execution of similar type of works as per categorization, detailed herein under.
- 2. a. Separate Tender should be submitted for each work, as per attached List, in sealed cover super scribing the name of the work on the envelope and addressed to the proper authority.
 - b. Submission of Tender by Post is not allowed.
- 3. The Tender documents and other relevant particulars (if any) may be seen by the intending Tenderers or by their duly authorized representatives during office hours between 11.00 A.M and 3:00 P.M on every working day, till 13.01.2025 in the office of the Assistant Engineer-I, Purulia Irrigation Division. They may also visit the official website of the Irrigation & Waterways department, Govt. of West Bengal www.wbiwd.gov.in to locate the same tender.
- 4. a. Intending Tenderers should apply for Tender Papers in their respective Letter Heads enclosing self-attested copies of the following documents, originals of which and other documents like Registered Partnership (for Partnership Firms) etc. are to be produced on demand, as well as during interview (if any).
 - A. Professional Tax Payment Certificate (PTPC) or the PT payment challan/receipt for current financial year / waiver order of competent authority in other state as applicable.
 - B. Valid PAN Card, Tread license.
 - C. Valid 15(Fifteen) digit Goods and Service Tax Payer Identification Number (GSTIN) as per GST Act. 2017 and rules 'GST registration certificate' made compulsory by finance department, Govt. of West Bengal irrespective of finance turnover of bidders & latest authenticated GST return submission.
 - D. Three years authenticated Income Tax Return for current financial year or immediate preceding financial year of bidder.
 - ii. Credential certificate (100% Completion Certificate, BOQ/SOR & Work Order) for one single similar work worth at least 30% of the value of the work for which Tender Paper is desired, executed within last 5 (five) years (to be determined from the actual year of completion, considering current financial year as Year-1)
 - iii. A Statement showing number and value of works presently under execution by the Tenderer under the Irrigation & Waterways Department and other Government Departments / Organizations as stated in paragraph 4 (c) hereunder.
 - iv. Declaration by the Applicant to the effect that there are no other applications for Tender Paper for work in this NIT in which he/she/they has/have common interests. Failure to produce any of the above documents may be considered good and sufficient reason for non- issuance of tender paper.
 - v. Completion certificate(s) submitted by the tenderer should indicate the monetary value of the work executed within the last 5 (Five) years. Monetary value of the work will be further multiplied by the following factors to take care of the inflationary effects to arrive the net rational amount.
 - b. <u>Company Details comprising the following:</u>
 - A. Details for Consortiums formed out of Proprietorship Firms &/ Partnership Firms

Deed of Consortiums formed with Partnership Firms etc., and documents for their registration in the form of certified copy of 'Form No. VIII,' issued under the Indian Partnership Act, 1932 (Act-IX of 1932) by the Registrar of Firms, West Bengal having their registered office at P-15 India- Exchange Place, Todi-Mansion, 10th Floor, Kolkata 700001.

In case a contractor/bidder is yet to receive Form No. VIII, a "Memorandum" issued from the above office may also be accepted. However, consortiums submitting the Memorandum are also required to submit an undertaking in plain paper along with their application "Copy of Form No. VIII would be submitted to the Tender Inviting Authority before receiving final payment, in case found to be the lowest bidder L1 and the work is awarded in its favour. Any change in the constituent of the Consortium/Partnership Firm should also be intimated to the office of the Registrar of Firms, Kolkata prior to submission of application in the e-tender and a certified copy of the revised Form No. VIII showing changes in its constituents are required to be submitted. If the Consortium is yet to receive a certified copy of the revised Form No. VIII, it would be required to submit the aforesaid undertaking on-line along with the application.

B. State Registered Co-operative Societies and Companies

- a. Society Registration certificate from ARCS of the State, Society by-laws, latest available Auditor's Report of Directorate of Co-operative Audit within proceeding five years as per Societies Act & Rules
- b. Trade License for Proprietorship Firms/Partnership Firms/Companies.
- c. 'Memorandum of Articles' for Companies registered by the ROC under Indian Companies Act.
- d. Any other documents showing names and signatures of latest elected office bearers/Directors/Board Members.
- c. Completion certificate of work executed in Irrigation & Waterways Department will be considered. Completion certificate of works executed in other Departments of State Government or Organization like Public Works & Public Works (Roads) Departments, Public Health Engineering Department, Sundarban Affairs Department& other State Government Departments, Zilla Parishads, West Bengal Housing Infrastructure Development Corporation Limited (WBHIDCO), West Bengal State Electricity Distribution Company Limited (WBSEDCL), Kolkata Metropolitan Development Authority (KMDA), Kolkata Metropolitan Water Sanitation Authority (KMW & SA), Kolkata Municipal Corporation (KMC), Other Municipal Authorities, Local Panchayat Bodies, Hooghly River Bridge Commissioner (HRBC); Engineering Departments of Central Government and Organizations like Farakka Barrage Project (FBP) Authority, Railways, Kolkata Port Trust (KoPT); and Companies Owned and Managed by the State Government i.e. Mackintosh Burn Ltd., Westinghouse Saxby Farmer Ltd. & Britania Engineering Ltd. may also be considered. Such Completion Certificates are to be issued by an officer not below the rank of Executive /Divisional Engineers/ District Engineer/Project Manager of the other State/ Central Government Departments/Organizations. Such certificates are further to be counter signed by immediate superior authority of the issuing authority for all cases other than Direct State/Central Government Departments and Railways.

Over and above the completion certificates from the competent authority regarding payment received so far for work (even if the full payment might not have been received), supported by Bank Statement showing that the corresponding amount of payment has actually been deposited in the Bank, will have to be produced in the cases of works executed under Departments/ Organisations other than Irrigation & Waterways Department, failing which credentials may not be considered.

- d. Any suppression/misrepresentation of fact will automatically debar the applicant from participating in any Tender under the Division / Circle for at least 3 (three) years from the date of detection, in addition to such other penal action as the Government may deem proper.
- 5. Intending Tenderer not satisfied with the decision of the Tender Paper Issuing Authority may prefer an appeal to the next superior Officer, Concerned Chief Engineer will be the Appellate Authority for High value Tenders. Necessary communication regarding his appeal to the Appellate Authority must be brought to the notice of such Authority within two working days after the date of issue of tender paper,

and copy of such communication should also be submitted to the Tender Paper Issuing Authority within the same period, failing which no such appeal will be entertained.

- 6. a. Tender paper can be had on free of cost in the office of the Assistant Engineer-I, Purulia Irrigation Division within the specified date and time as per attached list by the intending Tenderers or by their duly authorized representatives.
 - b. No Tender Paper will be supplied by Post.
 - c. No tender paper will be issued on the date of opening of tenders after expiry of date and time mentioned in the notice.
- 7. Before submitting any Tender, the intending Tenderers should make themselves acquainted thoroughly with the local conditions prevailing, by actual inspection of the site and take into considerations all factors and difficulties likely to be involved in the execution of work in all respects including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local labourers and market rate prevailing in the locality etc. as no claim whatsoever will be entertained on these accounts afterwards. In this connection the intending Tenderers may contact the office of the undersigned up to 14.01.2025 up to 02:00 P.M. on any working day.
- 8. Demand Draft, Banker's Cheque, of schedule Banks guaranteed by the Reserve Bank of India may be accepted as Earnest Money and / or Security Deposit in favor of the Executive Engineer, Purulia Irrigation Division. Payment in any other form e.g. NSC, KVP etc. will not be accepted.
 - a. Earnest Money for works in open tender, as noted in the list of work, will have to be deposited by the Contractors.
 - b. The Tenderer should quote the rate both in figures and in words on the basis of percentage above/ below or at Par the Schedule of Rates attached with the Tender Form and also in the space provided in the Tender Form.
 - c. Any tender containing over writing is liable to be rejected.
 - d. All corrections are to be attested under the dated signature of the Tenderer.
 - e. Labour Co-operative Societies have been exempted from payment of EMD against all tenders of the State Government. These societies, if selected through open tenders will have to furnish requisite Security Deposit for performance of the work. Revisions and amendments made in the WBFR & DFPR 1977 from time to time by the Finance Department are binding and in case of any ambiguity the same should be brought immediately to the notice of this Department (As per I & W Department's Memorandum circulated vide No. 03(W)/2015-16 dated 18th November, 2015.)
- **9.** When a Tenderer signs his Tender in an Indian Language, the total amount tendered should also be written in the same language. In the case of illiterate Tenderer, the rates tendered should be attested by a witness.
- 10. The Tenderer who will sign on behalf of a company or Firm, must produce the registered documents (within 3 days from the date of opening the tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act, failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- **11.** Any letter or other instrument submitted separately in modification of the sealed tender may not be entertained.
- **12.** The Tenderer should submit a statement at the time of submission of his tender showing the Technical staff to be maintained for the work, with their technical qualifications, failing which the tender may be liable to rejection.
- **13.** Conditional Tender, which does not fulfil any of the above conditions, and is incomplete in any respect, is liable to summary rejection.
- 14. Royalty, Building & other Construction workers, Cass and all other statutory Levy/Cass etc. will have to be borne by the Contractor (he will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work).

Deduction of GST will be made as per notification of Finance Department. In terms of G.O. NO. 946/SIW dated 28.11.06 of the Deputy Secretary to the Govt. of West Bengal Irrigation and Waterways Department deduction of Cass @1% from the bill to be paid to the contractors under the building and construction works Welfare, Cessrules'2004.

- **15.** The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without assigning any reason whatsoever to the intending Tenderers and also reserves the right to distribute the work amongst more than one Tenderers.
- **16.** The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him.
- 17. The Tenders will be opened, as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives, who may be present at the time of opening and who may also put their signatures in the Tender Opening Register.
- 18. The successful Tenderer will have to execute the duplicate / triplicate / quadruplicate copies of his tender which will have to be obtained by free of cost in the office of the Assistant Engineer-I, Purulia Irrigation Division within 7 (seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
- 19. If any Tenderer withdraws his tender before its acceptance or refuses / fails to convert it into a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal / refusal / failure, he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- **20.** The successful Tenderer will have to abide by the provisions of the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972 and such other Acts as may be applicable, as will be in force from time to time.
- **21.** Materials such as Cement, M.S. Rod, R.C.C. Hume Pipes, M.S. Sheet Piles, etc. if available in stock, will be issued by the Department to the Contractor for the work as per issue Rate fixed by the Engineer-in-Charge Site of issue of materials as mentioned in the list of materials to be supplied Departmentally to the Contractor is furnished with the tender documents for the work. Any other materials not listed therein, if supplied by the Department, the issue Rate for such material will be fixed by the Engineer-in-Charge.
- 22. Hire Charges for Tools & Plants Machinery, if issued Departmentally, will be recovered from the Contractor at such rates as will be fixed by the Engineer-in-charge. The period of hire charges of all Tools & Plants Machinery issued from the Government godown will be counted from the date of their issuance from the God own and up to the date of return into the same godown and the hire charges will be recovered from the Contractor accordingly. All Tools & Plants Machinery issued to the Contractor must be returned in good condition. In the case of any damage, the cost of repair to such damage or replacement will be recovered from Contractor.
- **23.** In the following cases a tender may be declared informal and unacceptable.
 - a. Correction, alterations, additions, etc. if not attested by the Tenderer,
 - b. i. Earnest Money in for form of N.S.C. /Government Security etc. not held by the Tenderer and not properly pledged.
 - ii. Earnest Money in the form of Baker's Cheque. / Demand Draft, etc. which are short deposited and/or not deposited in favour of the Executive Engineer, Purulia Irrigation Division.

- c. If the Tender Form is not properly filled in respect of the general description of the work, Estimated Cost, Rate of deduction of security Deposit etc. in page-2 and other pages as are required to be filled in.
- d. If the specified pages of the Tender Document are not signed by the Tenderer.
- e. If the Tender is not submitted in a Cover properly sealed and the name of the work is not indicated on the cover.
- 24. For the return of the Earnest Money of the unsuccessful Tenderer (S), he/they is/are to apply for the same to the Assistant Engineer-I, Purulia Irrigation Division giving the reference to the work, N.I.T. No. date of tender, amount and mode of Earnest Money deposited all in a complete form. The Earnest Money of all Tenderers other than the lowest Tenderer in each case, may be refunded, after acceptance of the rate in the comparative statement, as early as possible.
- 25. To verify the competency, capacity and financial stability of the intending Tenderer (s) the tender paper issuing Authority may demand production of any necessary document (s) as it may deem necessary.
- 26. The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due to delay in payment will be entertained.
- 27. Clause 25 substituted and modified in accordance with the prevailing Government Order.
- 28. Earnest money already deposited during the tender shall be converted as a part of security money and additional security shall be deducted from the progressive bills @8% or such amount from each such bill, so that the total deduction together with the 2% EMD constitutes 10% of the tendered value of work as actually done.

Such tenderers may also be permitted to deposit further security so as to make total 10% of the tendered amount to avail the facility of no further deduction from the progressive bills subject to the condition laid down in 231(c) contained in the notification no. 03W dated. 18th January 2011 and subrule 229(iii) of I & W Department Code.

29. The "Additional Performance Security" to be deposited by the successful L₁ bidder, if the accepted bid value is below 20% of the estimated amount put to tender.

This Additional Performance Security shall be equal to 10% of the tendered amount i.e. the L_1 bid price. The Additional Performance Security shall have to be submitted by the selected bidder after issuance of Letter of Acceptance / Letter of Invitation (LoA / LoI) and before Award of Contract (AoC) in the form of "Bank Guarantee" of any schedule Bank, payable at Purulia or / in West Bengal, as per enclosed format (Annexure). If the bidder fails to submit the Additional Performance Security within the seven working days form the date of issuance of LoA/ LoI, its Earnest Money Deposit (EMD) will be summarily forfeited.

The said Bank Guarantee (BG) shall have to be valid up till the end of the Contract-Agreement period including extended time period till 100% physical completion of work in all respects and shall be renewed accordingly if required. The said Bank Guarantee shall remain in custody of the DDO & Executive Engineer Purulia Irrigation Division, which shall be return to the bidder/ contractor immediately after successful physical completion of the work as per contract.

If the bidder fails to complete the work successfully, this Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving suitable notice to the contractor / bidder agency.

Periodic Tax invoice/ bills containing bidders GSTIN & other details need to be submitted by the 30. supplier / Contractor / Agency / Bidder to the DDO for raising claims for receiving payments of works executed under the contract upon achieving physical milestone clearly showing separately the tax charged in accordance with the provision of the GST act 2017.

The payment of running account bill as well as final bill for any work based on progress and performance will be made accordingly to availability of fund and no claim due to delaying payment will be entertained.

- **31.** Tender paper issuing authority may issue tender paper for any serial even though it may not be preferred by applicant.
- **32.** Bid/Tender evaluation committee(TEC) for the bids invited by the Executive Engineer upto Rupees 100.00 Lakhs will be comprising of (i) Concerned Executive Engineer as chairperson & Convener. (ii) Concerned Assistant Engineer as Member (iii) Estimator / JE of the office of Executive Engineer of the Division as Member. Bid/Tender evaluation committee(TEC) for the bids below 5.00 Lakhs value invited by the Assistant Engineer will be comprising of (i) Concerned Assistant Engineer as chairperson & Convener. (ii) Concerned Sectional Officer / JE will be Member or any other evaluation committee constituted by the Department from time to time.

33. Categorization of Works: -

1. Earthwork: Earthwork in excavation / filling for embankment, canal, drainage channels executed

under Irrigation & Waterways Department.

2. Protection Works: All kinds of river / channel bank / embankment protection work (with boulder, CC

blocks, revetment works, sausages, brick blocks, dry brick pitching etc.).

3. Lining Work: All kinds of water face lining / brick block pitching / dry brick pitching, in irrigation

canal / drainage channel, etc.

4. Hydraulic Structures: Aqueducts, Regulators, Syphons, Bridges across Waterways, Sluices, Dams,

Barrages, etc.

- 5. M.S. Structural Works: Gates of all kinds, electrical installations, pumps and allied etc. machinery.
- 6. Building Works: All type of building construction & renovation

The above list is only indicative and not exhaustive.
