

TERMS AND CONDITIONS


1. The Rate should be quoted in words and figures, and it is to be valid for a minimum period of 6 (six) months from the date of Quotation.
2. The Contractor may inspect the site before submission of the Quotation with permission from the appropriate authority.
3. Test Certificate from the Manufacturer is to be submitted at the time of supply of materials, at their own cost.
4. Arrangement for approval of the sample should be made by the concerned suppliers at their own cost, if necessary.
5. Quantities mentioned in the Quotation may be reduced or increased at the time of placing the supply order.
6. All goods supplied will be subject to our approval and are liable to rejection if found below specification. Such rejection will be made at the cost and risk of the Quotationer, for which no claim will be entertained.
7. Only goods of standard and good quality will be accepted, inferior quality is not acceptable decision taken by the consignee in respect of the quality will be final.
8. OEM authorization certificate must be submitted along with the offer in case of authorized dealers, failing which their Quotation will be rejected.
9. The Agency will arrange for scaffolding work at their own cost for the installation of the system.
10. No advance payment will be admissible.
11. Item-wise rate for all the items should invariably be quoted.
12. Incomplete and Illegible quotations will be treated as informal.
13. Successful Quotationer (s) have to submit earnest money @ 2% (two percent) on the total quoted amount in favour of **Executive Engineer, Kangsabati Mechanical Division**, I. & W. Directorate in the form of Demand Draft on any nationalized bank prior to execute Formal Agreement in WBF No.2911/2908 in duplicate/triplicate within 15 (fifteen) days from the issue of placing Work Order and an amount of 8% of the work value will be deducted as Security Deposit. The agency may furnish a bank guarantee of an equal amount, which will be refunded on completion of 1 (one) year.


