**(ii) Publication of SNIT :**

- The Executive Engineers and Superintending Engineers are allowed to publish abridged tender notices of the aforesaid emergent works directly in print media instead of routing the same through I&CA Deptt. The cost of such advertisement may be borne out of the departmental budget provision under the detailed head '26'. The bills of these advertisements are to be sent to the Department for making the payment centrally.
- Tenders shall be invited by publication of the tender notice in the notice boards and by uploading the same in the official Departmental website. If there is reasonable apprehension that such notice would have inadequate response, direct communication, through messenger delivered letter or through e-mail to the bonafied and resourceful contractors, having sufficient experience of execution of such works, at a very short notice, may be contemplated, provided that all such steps shall not encourage enlistment of contractors that has since been abolished.

**ELIGIBILITY CRITERIA OF THE TENDERER PARTICIPATING IN THE TENDERS INCLUDING SOME TERMS AND CONDITIONS**

**5. Eligibility for participation**

Bona fide outside Contractors, Registered Engineers Cooperative Societies, Consortiums and Partnership Firms registered with the State Government and contractors of equivalent Grade / Class registered with Central Government / MES / Railways for execution of civil works are eligible to participate. **Joint venture firms are not eligible to participate.**

*(In case of consortiums, maximum number of constituents shall be restricted to 5 (Five) and each constituent must have at least some credential towards contracting business. Individual constituent of a consortium cannot be another consortium.)*

**6. Participation in more than one work**

Any contractor can submit tenders for a maximum of 50% of the total number of works (rounded up to next higher integer) published in any particular NIT, depending on his credential and financial capability, details of which are given later

**7. Application for purchase of Tender forms**

**A)** Intending Tenderers have to be submitted application duly enclosed with the self-attested copies of the following documents addressed to **the Executive Engineer, Berhampore Irrigation Division, Berhampore, Murshidabad.**

**B) Copies of documents:**

V.A.T /G.S.T., P.T. (Professional Tax) Clearance Certificate and IT PAN valid at least up to the date of opening of Tenders should be considered, Registration of Partnership Deed (in case of Partnership Firm), Power of Attorney, Registration of Firm, By-Laws (in case of Engineers Co-Operative), Profit & Loss Account & Audited Balance Sheet of any 3 (three) Financial years within zone of preceding 5 (five) years duly authenticated by Licensed Auditor regarding annual Turnover. Properly filled up Form-1 (Application for Tender) to be submitted in plain paper or in letterhead pad, Form-2 (Declaration against Common Interest), Form-3 (Power of Attorney), if applicable, Form-4 (Declaration of antecedents and performance).

### C)Pre Qualification (PQ) eligibilitycriteria

Prequalification (PQ)eligibilityof a contractor/ bidder based on one single 100% completed works contract and financial capacity achieved within the zone of last five financial years will be determined as per Rules stated below:

- i) Firstly, the gross value of the work submitted as PQ Credential as per CC of similar in nature completed during the current financial year before date of publishing of SNIT or within the preceding five FY will be multiplied by the following factors to take care of the inflationary effects to arrive at the gross notional amount

**Note:** For cases where two contractors/bidders are participating in a Tender for a particular work are such that one happens to have worked as a sub-contractor of the other, and both the contractors/bidders submit PQ work credential of having completed the same job either wholly or partly, then in such case the PQ credential of the principal contractor will be considered while that of the sub-contractor will not be taken into consideration for determining the eligibility criteria of the contractor/bidder during technical evaluation of the tender. If the PQ Credentials submitted by hitherto contractors/bidders are for different works, then both the PQ Credentials will be considered for determining the eligibility criteria of the individual contractors/bidders.

- ii) Gross notional amount calculated from the Credential Certificate (CC) uploaded as the PQ Credential of a single similar work stated in 7(c)(i) above and completed within immediate five preceding financial years on the date of SNIT, **should be at least 30% of the amount put to tender i.e Tender Value**. However, for Consortium/JV where CC of individual entities of the Consortium/JV are to be considered, sum of gross notional value of work in respect of the CC of individual entities for works of similar in nature (one for each entity), aggregate should be at least **60%** of the amount put to tender for which the tender is invited

### D) Guidelines for ascertaining works of similar in nature

- (I) Following major items/conglomeration of items having weight age of 25% or more in terms of monetary values in respect of amount put to tender for a work are to be identified and the monetary value of each of the major item is to be calculated by the Tender Inviting Authority for any particular serial of work listed in the SNIT by summing up the associated items of the BOQ coming up under any of the major items as described below:
  - a. (i) Type-A Earthwork(relevant to and required for construction / repair / improvement / reconstruction of all types of embankments and land filling or land development:  
Earthwork in embankments along canals, channels, rivers, reservoirs, earthwork in excavation or

desiltation of ponds (exceeding 5 hectares), earthwork for land filling and development (exceeding 10 hectares) and earthwork in road / railway embankments or guide bundhs including items of leads, lifts, disposal and transportation but excluding earthwork in foundation filling or excavation in case of all structures including industrial structure.

(ii) Type-B Earthwork (relevant to and required for re-excavation / desiltation / dredging of canals / channels / rivers / barrage ponds).

Earthwork in excavation / re-excavation / desiltation / dredging of canals / channels / rivers / seafront / barrage ponds but excluding ponds and lakes, in dry or wet condition, including items of leads, lifts, disposal and transportation.

Note: Credential for 'Type-B' earthwork may also be considered to ascertain similarly for works including 'Type-A' earthwork but 'vice-versa' cannot be considered. In order of words, bidders having credential of 'Type-A' earthwork will not be eligible for works involving 'Type-B' earthwork.

- b. Brickwork / Boulder Masonry Work (other than in Buildings): Brickwork/boulder masonry work and cement plaster.
- c. Concrete work (including reinforcement and allied works in case of piling) other than those for buildings: PCC inclusive of shuttering, formwork with staging, RCC of all grades inclusive of all reinforcements & insert plates & formworks- shuttering with staging complete & MS liners for bore piles & MS or special alloy sheet piles as cut-off walls or retaining walls in all types of structures, concrete pavement and protection works, but excluding concrete works included under Cl. 7 II (g) below.
- d. Structural Steel works: All types of structural steel works including cast iron components but excluding reinforcement rods and all types of MS sheet piles which is included in protection work.
- e. Protection work: All types of river/ canal / pond / embankment / road / coastal protection works using PCC / RCC / Bricks / Boulders / Bats / Polythene / Polypropylene / HDPE / Nylon / Jute / geo-jute / Bullah / MS sheet piles / Bamboos.
- f. Road work: All types of bituminous road / rigid pavement using RCC / PCC / other type of roads using boulder / brickbats / whole bricks / jhama bats / riverbed materials / moorum. In case of construction of PCC pavement upto maximum width of 3.5 m and meant for only 4-wheeler having Gross Vehicular Weight not exceeding 5.5 MT (maximum Axle Load of 3.5 MT, rates as 5R bridge as per IRC-6), PCC/RCC works executed in protection / lining / any other structures including building may also be considered in addition to the criteria stated in the foregoing sentence of this Para.
- g. Building work: All items related to brickwork, cement work including PCC and RCC, formworks, staging, shuttering, plastering, carpentry works, painting and flooring, plumbing, electrical connection all finishing items fittings & fixtures except draperies & furniture complete.
- h. Any other major item or conglomeration of items not mentioned above, namely procurement of goods, equipments, machineries, Tools & Plants, Mechanical, Electrical works, specialized jobs, Fitting, Fixtures etc determined as Major items in respect of the SOR/BoQ of tendered items fulfilling the required criteria.
- j. Any other item contained in the PWD (SoR) or the I&WD, USoR not included herein above will be decided by the HTEC/TEC with recommendation of Chief Engineer concerned.

Note: Mechanical and Electrical Circles are required to suitably prepare major items based on the above principle.

**(II) Monetary values of each of the 'major items' or 'conglomeration of items forming a major item' contained in the 'BOQ' of this tender is to be multiplied by a factor 0.40 to arrive at the minimum required Technical PQ Credential in terms of execution of similar items and clearly stated in absolute terms as amount in rupees in column 8 of 'List of Works'.**

- (III) If value of summation of those items contained in the BOQ of the AOC submitted by the bidder as its PQ Work Credential matches with at least one of the major items or conglomeration of items stated in the minimum PQ Credential at column 8 of the 'List of Works' in the e-tender and is equal to or exceeds the amount of any one of the PQ financial eligibility criteria specified at column 8, bidders PQ Credential may be considered as similar in work subject to fulfilment of the following conditions:
  - a. After summation, the value may further be multiplied by the factors stated in the table under clause 7 (c)(i) to take care of the inflationary factors.

- b. Whenever PQ Credential of individual entities of a Consortium/Joint Venture is considered, multiplying factor of 0.30 stated in Clause 7 III should be considered as **0.60** of combined values of the BOQ.

**Note:-**

- i. If the items of work contained in the tender are such that even after combination and addition of those into categories of major items defined as illustrated in clause 7 II, the aggregate amount being less than 25% of the amount put to tender, the Tender Accepting Authority shall decide on appropriate major items, one or two among the list of predominant items in the tender BOQ and direct the Tender Inviting Authority to fix the financial PQ eligibility requirement (monetary value of such items) accordingly in column No. 8 of the list of works of the tender for determination similar nature.
- ii. Eligibility for similar nature of work will be judged on the basis of items of works in the BOQ/SoR of the that particular serial of work in the e-tender, mentioned in absolute terms in rupees, and the corresponding Major items with that of the AOC with BOQ uploaded by the bidder as PQ work Credential in support of the CC.

**E) Additional eligibility criteria**

- i) List of Tools & Plants, Machinery, and Equipment etc. in possession.
- ii) List of Technical & Non-Technical staff.
- iii) List of works in progress with their respective value.
- iv) Eligibility certificate/N.O.C. issued by the A.R.C.S.(for Engineer's Co-operative only)
- v) A Statement showing number and value of works presently under execution by the Tenderer under the Irrigation & Waterways Department and other Govt. Department/Organizations.
- vi) Declaration by the applicant to the effect that there is no other applications for Tender Paper for work in the N.I.T. in which he/she/they has/have common interests and in that case intending Tenderer has to disclose his/her name(s) and style of another firm/individuals (where he is also officiating) in the application for issuing Tender forms failing which the decision of the committee regarding the matter will be final and binding upon all.
- vii) Declaration by the contractor to the effect that he/they has/have no near relative is posted in any offices under the circle which intends to submit tender. In case of near relative posted in any offices under the circle, he/they will not be permitted to Tender for works in the circle of the Superintending Engineer.
- viii) Completion Certificate of work executed in other Departments of State Government or organizations, like Public Works & Public Works(Roads) Department, Public Health Engineering Department, Sundarban Affairs Department and various other State Govt. Departments, ZillaParishads, West Bengal Housing Infrastructure Development Corporation Limited (WBHIDCO), West Bengal State Electricity Distribution Company Limited (WBSEDCL), Kolkata Metropolitan Development Authority (KMDA), Kolkata Metropolitan Water Sanitation Authority (KMWSA), Kolkata Municipal Corporation (KMC), Hooghly River Bridge Commissioner (HRBC) Engineering Departments of Central Government and Organization, like Farakka Barrage Project (FBP) Authority, Railways, Kolkata Port Trust (KPT), and companies owned or managed by the State Government, i.e Mackintosh Burn Ltd., Westinghouse Saxby Farmer Limited & Britannia Engineering Ltd. May also be considered. Such Completion Certificates are to be issued by an officer not below the rank of Executive Engineer/Divisional Engineer/District Engineer/Project Manager of other state/Central Govt. Departments/Organizations. Such certificates are further to be countersigned by immediate superior authority of the issuing Authority for all cases other than direct/State/Central Govt. Department and Railways.

**8. Eligibility criteria based on average annual financial turnover of the bidder:**

- a. Apart from satisfying eligibility criteria based on PQ Credential stated in Clause 7 C to D, the Annual financial Turnover requirements stated below must also be satisfied to declare a bidder qualified for a particular work in financial bid stage.
- b. **Average of Annual turnover from business of any three FY with the zone of immediate preceding five FY as stated in clause 7 B(IV) should be at least 30% of the amount put to tender of work in which the bidder intends to participate.** However, for Consortium/JV, such Average Annual Turnover should be at least 90% of the amount of tender in which the Consortium /JV intends to participate and each entity should have 20% of required Average Annual Turn Over for three preceding financial years. Documents sought under Technical & OID cover folders are mandatory for all the entities of the Consortium/JV.

- c. **'Net financial worth' of the bidder should be positive in the three financial years for which the Annual turn over documents referred under 8b. have been uploaded, for qualifying in technical bid. It would inter alia mean that the total assets of a financial year minus Gross total liabilities as per Audited Balance Sheet should be of positive value.**

**9. Scope of disqualification for issuing Tender Forms: -**

- i) Delay submission of application (after expiry of the schedule Time)
- ii) Insufficient and improper documents submitted with the applications.
- iii) Non-submission of completion, payment certificate and schedule of work properly.
- iv) Old completion certificate and payment certificate.
- v) Submitted documents along with application for tender paper without signature of the applicant.
- vi) Non-submission of copies of valid Partnership Deed and respective Firm Registration Certificate from the Registrar of Firms, West Bengal. Submitting amended Partnership deed, if any without submitting original Partnership deed with the application of tender form.
- vii) Non-submission of certified documents for State registered Co-operative Societies stating the name of the latest Society members along with Society registration certificate by A.R.C.S. & Bye-laws with latest Audit report.
- viii) Submission of loose documents with application paper for tender.
- ix) Any other discrepancies found in the application for issuing of tender papers.
- x) Verification of original documents not done / improperly done.
- xi) Mismatch in original documents with submitted documents.
- xii) Mismatch in name & surname by spelling in all relevant documents.
- xiii) Submission of invalid documents.
- xiv) Furnishing defective credential.
- xv) Non submission of any of the Form-1, Form-2 & Form-4 as stated in the NIT along with application for tender paper

Any other causes if found in the application which may lead to rejection for issuing tender paper including the clauses mentioned in the NIT.

**10. Fulfillment of Criteria and issue of Tender Paper:-**All the above as stated under Para-9 are to be fulfilled properly, pending fulfillment of which Tender Forms may not be issued.

**11. Order for issue of Tender forms:-**The application of the intending tenderer along with the all documents so received by the office of the undersigned will be verified by the office of the undersigned and after the decision of the undersigned for issuance will be final & bindings.

**12. Not satisfied with the decision of the committee for issuing Tender Paper:-**Within 24 hours of publishing the list of qualified bidders, any of the aggrieved bidder, may seek clarification / redressal / review from the TIA, in writing/through e-mail with supporting facts / figures / documents.

**13. Issue of Tender forms:-**Tender documents etc. will however be available and be issued from the office as stated above. The intending Tenderers are requested to present themselves personally or send their authorized representative to that office to receive the tender form within the time schedule.

**14. Inspection to Site by the intending Tenderer before submitting Tender:-**Before submitting any Tender, the intending Tenderers should make himself/themselves acquainted thoroughly with the local conditions prevailing, by actual inspection of the site and take in to considerations all factors and difficulties likely to be involved in the execution of work in all aspects including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local laborers and market rate prevailing in the locality etc. as no claim whatsoever will be entertained on these accounts afterward. In this connection the intending Tenderers may contact the office of the undersigned up to last date of issue of Tender Forms between 11.30 hours and 16.30 hours on any working day.

**15. Earnest Money& Security Deposit :** - In partial modification of Notification No. 03-W dated 18<sup>th</sup> January 2015 of the Secretary to the Govt. of West Bengal, Irrigation & Waterways Directorate communicated by the Deputy Secretary to the Govt. of West Bengal, Irrigation & Waterways Directorate vide Memo. No. 89(6)-IB/IW/O/1B-Misc-12/2007 dated 18<sup>th</sup> January 2011; subrule229 (iii) vide memo no: - 08/1(6)-IB dt.30.04.2013 the following provisions have been made in different para's and that should be abided by the tenderer.

- a) **DEPOSIT OF EARNEST MONEY:-** An Earnest Money amounting to 2% of the estimated cost put to tender so long as the estimated cost put to Tender is up to Rs. 25.00 Crore and amounting to Rs. 50.00 lakh plus 1% of the excess of estimated cost over Rs. 25.00 Crore.
- b) **DEPOSIT OF EARNEST MONEY & SECURITY DEPOSIT IN CASE OF UNEMPLOYED ENGINEERS CO-OPERATIVE SOCIETIES:-** The above Co-operative Societies will have to be deposited the earnest money and Security Deposit as per the Notification No. 03-W dated 18<sup>th</sup> January 2015 of the Secretary to the Govt. of West Bengal, Irrigation & Waterways Directorate communicated by the Deputy Secretary to the Govt. of West Bengal, Irrigation & Waterways Directorate.

c) DEDUCTION OF SECURITY MONEY FROM THE PROGRESSIVE BILL:

Earnest money already deposited during the Tender shall be converted as a part of security money and additional security shall be deducted from the progressive bills at 8% or such amount from each such bill, so that the total deduction together with the 2% E.M.D constitutes 10% of the tendered value of work as actually done as per Finance Department (Audit Branch), Govt. of West Bengal's memo no. 201-F(Y) dated 18.01.2021.

d) NO FURTHER DEDUCTION SECURITY MONEY FROM THE PROGRESSIVE BILL:- In partial modification of sub rule 231(b) enumerated in this Departmental Notification No-03-W Dt. 18<sup>th</sup> Jan 2011, such Tenderers may also be permitted to deposit further security so as to make total 10% of the Tendered amount to avail the facility of no further deduction from the progressive bills, subject to the condition laid down in 231(c) contained in the above said notification.

e) SHAPE OF EARNEST MONEY:- In para (11), **Demand Draft, Banker's Cheque, and Treasury Challan, Deposit at Call Receipt (D.C.R.)** of Scheduled Banks guaranteed by the Reserve Bank of India may be accepted as earnest money and/ or security Deposit.

In terms of Memo. **16. Dropping of Tenders:-**Tender that should always be submitted in sealed cover with the name of work clearly written on the body of the W.B.F. No.2911(ii) stated above as well as on the envelope will be dropped in the following offices on the schedule Date & Time as stated in Para (3) above and or the changing schedule made vide issuing necessary CORRIGENDUM.

(iii) Superintending Engineers are authorized to accept short notice offline tenders, with minimum notice period of 3 days with adequate publicity including that in notice-board, newspaper and departmental website, for undertaking emergent works as defined under Para 2 (B) above, of amount put to tender exceeding Rs. 20.00 Lakh but limited upto Rs. 40.00 Lakh, in each case, subject to obtaining prior consent and a post facto written approval of the concerned Executive Engineer.

**19. Additional Performance Security:** The additional performance security shall be obtained from the successful L1 bidder, if the accepted bid value is below 20% of the estimated amount put to the tender. The additional performance security shall be equal to 10% of the tendered amount i.e. the L1 bid price. The additional performance security shall have to be submitted by the selected bidder after issuance of letter of acceptance/letter of invitation (LoA/Lol) and before award of contractor (AoC) in the form of "Bank Guarantee" of any Scheduled Bank, payable at Kolkata or / in West Bengal, as per enclosed format (Annexure). ### **OTHER TERMS & CONDITIONS.**

**25. In Terms of vide memo no:-46(5)-IB dt. 11<sup>th</sup> june-2012, of Deputy Secretary to the Govt. of west Bengal, Mackintosh Burn Ltd., Britannia Engineering Ltd. And Warehouse Saxby Farmer Ltd. Will not enjoy 10% preference in rate for the purpose of selection.**

**26. Any suppression/misrepresentation of fact will automatically debar the applicant for participating in any Tender under the Division/Circle for at least 3(Three) years from the date of detection, in addition to such other penal action as the Government may deem proper.**

**27. Intending Tenderers should be equipped with plants, machinery equipment and well point pumping machinery complete with all accessories as required for the work as the department may not be in a position to issue such plants & machinery. They must submit a list of such plants; machinery and equipment in their possession for necessary documentary evidence are to be produced.**

**28. If required, the intending Tenderers have to be produced Bank solvency certificate of an amount equal to 30% of the estimated amount of the work.**

**29. Documents submitted along with the application should invariably be in the name of the applicant firm/ Individuals. In terms of Memo. No. 185/JS(W)/IA-11C-9(75)/09 dated 09.06.09 of the Secretary**

to the Govt. of West Bengal, I&W.D, Joint venture of Firms constituted and duly registered with the appropriate authority will be considered for issuance of Tender Papers.

30. **All pages of the documents submitted with the application shall be signed with signature by the applicant or by his authorized signatory and also be serially numbered as 1/10, 2/10, 3/10.....10/10**
31. Copies of Partnership Deed and Firm Registration duly self-attested shall invariably be submitted with the application by a partnership firm.
32. Tenderers should quote their rates both figures and words in terms of overall percentage, "below" or "above" or "at par" with the price schedule both in the 2<sup>nd</sup> page of W.B.F 2911 (ii) and the last page of price schedule.
33. Any tender containing over writing is liable to be rejected.
34. All corrections are to be attested under the dated signature of the tenderer.
35. When a Tenderer signs his Tender in an Indian Language, the Total amount tendered should also be written in the same language. In case of illiterate Tenderer, the rates tendered should be attested by a witness.
36. The Tenderer who will sign on behalf of a Company or Firm, must produce the registered documents within 3(Three) days from the date of opening the tender, if not submitted with the tender application or with the Tender documents) in support of his competency to enter in to an Agreement on behalf of the Company or the Firm under the Indian Companies or Partnership Act, failing which the tender will not be considered and the deposited Earnest Money will be forfeited.
37. The rate quoted by in the tender form will be final and no subsequent modification in the rates will be entertained even it is done with any letter or other instrument submitted before sealing/closing the Tender box.
38. Any superfluous conditional tender, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to be rejected.
39. VAT, Royalty, and all other statutory Levy/Cess etc. will have to borne by the Contractor. The engaged Contractors need to get registered under BOCW (RECS) Act and shall have to contribute towards a fund namely **"The West Bengal Building & other Construction worker's Welfare Fund"** @1.00%(one point zero percent) of the total amount of the work value which will be deducted directly from the bill value and remitted as per requirement of the said Act as per Finance Department Notification No. 853-F dated 01.02.06.
40. Canvassing in connection with the tenders is strictly prohibited and the tenders submitted by a tenderer who take resort to canvassing will be liable to rejection.
41. Incomplete and illegible tender will be invalidated. All corrections in the tender should be signed with dated initial by the contractors before submission of tender and each page of the tender should also be signed and dated by the contractor.
42. The contractor has to obtain the Labour license from the office of the Joint Labour Commissioner of the concerned District in which the location/site of the work falls, under the provision of W.B. Contract Labour (Regulation & Abolition) rules, 1972 and a copy of the license has to be submitted to this office for information & record, failing which the undersigned will in no case be hold responsible for any action taken by the Labour Department. The undersigned being the **'Principal Employer'** for the work, will however issue a certificate in specified pro forma of Labour Department in form V for doing the needful by the authority of labour Department.
43. As per rule, the intending tenderer has to disclosed his/their name (s)& style of another firm /individuals (where he is also officiating) in the application for issuing tender forms failing which the decision of the undersigned regarding the matter will be final & binding upon all.
44. The Tenderer should submit a statement at the time of submission of his tender showing the Technical Staff to be Engaged for the work, with their Technical qualifications, failing which the tender may be liable to rejection.
45. The Tenderer will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him/them.
46. The Tenders will be opened, as specified in the list of works, in presence of the Participating Tenderers or their duly authorized representatives, who may be present at the time of opening and who may also put their signatures in the Tender opening Register.
47. The successful Tenderer will have to execute the tender agreement in quadruplicate of his /their tender which will have to be obtained by free of cost from the office of the **concerned Executive Engineer**, within 7(seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
48. If any Tenderer withdraws his tender before its acceptance or refuses/fails to convert it in to a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal/refusal/failure, he shall be disqualified for submitting any tender in this Division/Circle for

a period of 1(one) year and his/their case will be referred to the Government for order as to what further action will be taken against him/them.

49. Materials such as cement, M.S. Rod, R.C.C. Hume Pipes, M.S. sheet Piles, etc. if available in stock, will be issued by the Department to the Contractor for the work as per issue rate fixed by the Engineer-in-charge. Place of issue materials as mentioned in Page 11 of W.B.F. -2911(ii) or in a separate sheet attached with the Tender documents to be supplied departmentally to the Contractor is furnished with the Tender documents for the work. Any other materials not listed therein, if supplied by the department, the issue rate for such materials will be fixed by the Engineer-in-charge.
50. Hire charges for Tools & Plants Machinery, if issued departmentally, will be recovered from the contractor at such rate as will be fixed by the Engineer-in-charge. The period of hire charges of all Tools & plants Machinery issued from the Government go-down will be counted from the date of their issuance from the go-down and up to the date of return in to the same go down and the hire charges will be recovered from the contractor accordingly. All Tools & plants Machinery issued to the contractor must be returned in good condition. In the case of any damages, the cost of repair to such damage or replacement will be recovered from the contractor.
51. In the following case a tender may be declared '**INFORMAL**' and unacceptable.
  - a) Correction, alterations, additions and overwriting etc. if not attested by the tenderer.

  - d) (i) If, the Tender is not submitted in a cover properly sealed.  
(ii) If, the name of the work with N.I.T. No. & Serial No. of the work and the name of the addressee with the name of the Senders (Tenderers) are not exactly written on the envelope.
52. a) In terms of the provision in Para 230 Page of I&W.D. Code Volume- 1 and at the same time provided in Para 150(3) of W.B. Works Departmental Manual, the Earnest Money of all the Tenderers other than the three lowest Tenderer should be refunded after the comparative statement has been prepared and checked and,  
(b) In terms of the provision laid down in Para 5 of the 1<sup>st</sup> page of W.B.F. 2911. In case of rejected Tender it should be refunded within 10(ten) days from the date of decision.
53. To verify the competency, capacity and financial stability of the intending Tenderers the Tender paper issuing authority may demand production of any necessary documents as it may deem necessary.
54. As per G.O. No. 1627(8)/1A dated 26<sup>th</sup> November 2001 of Irrigation & Waterways Department, Government of West Bengal, Clause 25 of Tender Form No. 2911(ii) stand deleted in respect of contract of value less than 100.00 lakh.
55. Normally Tender Paper for not more than one work in any one N.I.T. will be issued to an applicant, who may indicate the Serial Nos. of the work in the order of priority. However, depending on response to various serials in the N.I.T., Tender Paper issuing Authority may issue Tender Paper for any serial even though it may not be preferred by the applicant.
56. Tender may be cancelled in any stage without assigning any reason.
57. Any discrepancies if found, in the documents/statement the tender shall be cancelled in the subsequent stage with imposition of lawful action for this act of submission of documents.
58. Apart from all the above conditions and criteria the 'Past and Present' performance of the agencies will be considered while issuing tender papers.
59. The payment of R/A as well as Final Bill for the work will be made according to the availability of fund and claim due to delay in payment will not be entertained.
60. Subletting of work is strictly prohibited & will be viewed seriously & disqualify the agency to participate in the next Tender.
61. Canvassing in connection with Tender is strictly prohibited and the Tenders submitted by a Tenderer who will resort to canvassing will be liable to rejection.
62. All specifications, Terms and conditions etc. of the printed schedule of rates (USoR) of Irrigation & Waterways Department, P.W.D., P.W.D. (Roads), will be applicable, unless otherwise specified.
63. Apart from all the above, only in the interest of the Government, the committee may allowed purchasing Tender Forms to such agency/agencies who/they will fulfilled the other criteria and his/their Past or Present performance is/are satisfactory but his/their credentials in regards to completion and Payment certificates stand less than the requirement.
64. All applicants willing to participate in the Tender must have to be appeared before a Tender document scrutiny committee for verification of original of the submitted documents. In case, the applicant or his authorized person not appeared before the tender documents scrutiny committee

with the original documents in the schedule date and time as stated under para-3 (ii), the application will be disqualified for issuing tender form.

65. **Tender forms will not be issued after due date and no tender forms will be sent by post.**
66. Notification No. 11-W/2023-24 Dt. 30.06.2023 will be imposed on SNIT.
67. **Contractor(s) should have to ensure the mandatory engagement of job card holders as unskilled workers for execution of awarded work, in order to implement the “Karmashree” Scheme launched by the State Government. They also have to submit periodic statement on such engagement to the Engineer-in-Charge in the prescribed format (details are stated in I&W Dept.’s Memorandum No. 20-W/2024-25, dated 19.07.2024).**
