SHORT NOTICE INVITING TENDER No. WBIW/SE/DIC/SNIT-02/2025-26

Separate sealed tenders in printed form are invited by the **Superintending Engineer**, **Damodar Irrigation Circle (Off Line Short Notice as per G.O. No.-** 11-(W)/2023-24, **Dated on 30th June,2023** of **Principal Secretary of the Irrigation and Waterways Department, Govt. of West Bengal** along with U.O No-T/2023-2024/0312 **Dated 26.06.2023 of Finance Dept Govt of WB and 292(9)-IB dated** 17.06.2025 of **Deputy Secretary I&WD**) on behalf of the Governor of West Bengal for execution of emergent restoration works within the minimum possible time as per list attached herewith from the Bonafide Outsiders having credential of similar nature of work, of value 50% of the amount put to tender within last 5 years

- 1. Separate tender should be submitted for each work, as per attached list, in sealed cover super scribing the name of the work on the envelope and addressed to the **Superintending Engineer**, **Damodar Irrigation Circle**, **Kanainatsal**, **Purba Bardhaman**.
- 2. Submission of tender by post is not allowed.
- 3. The tender documents and other relevant particulars (if any) may be seen by the intending tenderers or by their duly authorized representatives during office hours between 11.00 AM and 5.00 PM on every working day, till **13/10/2025 up to 15:00 Hrs** in the office of the Superintending Engineer, Damodar Irrigation Circle, Kanainatsal, Purba Bardhaman.
 - a. The intending tenderer must have up to date trade license, otherwise his application will be rejected and must enclose copy of trade license with application. The intending tenderer should apply for tender papers in their respective 'Letter Heads' enclosing self attested copies of the following documents, originals of which and other documents like Registered Partnership (for partnership firms) etc. are to be produced on demand, as well as during interview (if any).
 - i. Professional Tax Challan, latest authenticated Income Tax Return for current financial year or immediate preceding financial year, PAN Card, Goods and Service Tax (GST) Registration Certificate with **upto date valid GST return**, Proprietorship Firms (Trade Licence), Partnership Firms (Partnership Deed, Trade License, Form-VIII or Memorandum of Registration), Limited Companies (Incorporation Certificate, Trade License, Memorandum of Articles), Registered Co-Operative Societies (Society Registration Certificate from ARCS of the state, latest available Auditor's Report of Directorate of Co-operative Audit within proceeding five years as per Societies Act & Rules., Trade License and By-Laws, Documents showing latest office bearers) valid up to the date of opening of the tenders. Application for such clearance addressed to the competent authority, subject to production of authenticated receipt, may also be considered.
 - ii. Completion certificate / Payment certificate(s) for one single similar work with value of work equal to or more than the value specified in Eligibility of Contractor(Column-8)in List of Works ,for which tender paper is desired, executed within last 5 (five) years (to be determined from the actual year of completion, considering current financial year as Year-1).
- iii. A statement showing number and value of works presently under execution by the tenderers under Irrigation & Waterways Department and other Government Department / Organizations as stated in paragraph 3 (b) hereunder.
- iv. Declaration by the applicant to the effect that there is no other application for tender paper for work in this NIT in which he/she/they has/have common interest. Failure to produce any

of the above documents may be considered good and sufficient reason for non issuance of tender paper.

- b. Completion certificates of works executed in the Irrigation & Waterways Directorate will be considered. CC of works executed in other Departments of the State Government/ organizations viz. Public Works & Public Works (Roads) Department, Public Health Engineering Department, Sundarban Affair Department and other State Government Departments, Zilla Parishads & Panchayat Samities only within the jurisdiction of the State of West Bengal, WBHIDCO, WBSEDCL,WBSETCL, KMDA, KMW&SA, KMC, Other Municipal Authorities and Bodies, HRBC, Engineering Departments of Union Government and Organizations like Farakka Barrage Project (FBP) Authority, Indian Railways, KOPT and companies owned or managed by the Government of West Bengal, i.e. Mackintosh Burn Ltd., Westinghouse Saxby Farme Limited & Britannia Engineering Ltd. may also be considered. Such CC is to be issued by an officer/authority not below the rank of Executive Engineer / Divisional Engineer / District Engineer/Project.
- c. Manager of the State/Union Government Departments/ Organizations; authorized signatories of CC for Panchayat Samities and Municipalities shall be BDO & Ex-officio Executive Officer and Secretary or equivalent administrative officers respectively. It is desirable to have contact telephone and FAX or e-mail address of the signatory of the CC for all offices outside West Bengal.

 Such Complication Certificate is required to be further countersigned by the immediate superior authority of the issuing authority for all cases other than direct Union Government Departments / Ministries outside the State of West Bengal. Also such certificates when issued in all other States other than those directly of State / Union Government Departments/Ministries and Indian Railways should contain a declaration that the work has been executed to the satisfaction of the concerned Government Organization and has been declared 100% complete in all respect by the competent authority in the concerned Organization.
- d. Any suppression / misrepresentation of fact will automatically debar the applicant from participating in any tender under the Division / Circle for at least 3 (three) years from the date of detection, in addition to such other panel action as the Government may deem proper.
- 4. Intending tenderers not satisfied with the decision of the tender paper issuing authority may prefer an appeal to the next superior officer. Concerned Chief Engineer will be the appellate authority for high value tenders. Necessary communication regarding his appeal to the appellate authority must be brought to the notice of such authority within two working days after the date of issue of tender paper and copy of such communication should be submitted to the tender paper issuing authority within the same period, failing which no such appeal will be entertained.
- 5. a. Tender paper can be taken from the office of the Executive Engineer II, Damodar Canal Division, within the specified date and time as per attached list by the intending tenderers or by their duly authorized representatives.
 - b. No tender paper will be supplied by post.
 - c. No tender paper will be issued on the date of opening of tenders after expiry of date and time mentioned in the notice.
- 6. Before submitting any tender, the intending tenderer should make themselves acquainted thoroughly with the local conditions prevailing, by actual inspection of the site and take in to considerations all factors and difficulties likely to be involved in the execution of work in all respects including transportations of materials, communication facilities, climate conditions, nature of soil, availability of local laborers and market rate prevailing in the locality etc. as no claim whatsoever will be entertained on these accounts afterwards. In this connection the intending tenderers may contact the office of the undersigned up to 13/10/2025 between 10:00 hours 15.00 hours on any working day.
- 7. Earnest money, as noted in the list of works, Earnest Money Deposit (EMD) must presently be submitted in the form of Bank Draft (BD) / Bankers Cheque (BC) / Deposit Call Receipt (DCR) of any scheduled Commercial Bank in India approved by RBI & having a branch in West Bengal which is to be drawn in favour of **The Superintending Engineer**, **Damodar Irrigation Circle**. Payment in any other forms viz. NSC, KVP, cheques etc. will not be accepted. Labour Cooperative Societies and State Government Enterprises viz. Mackintosh Burn Limited, Westinghouse Saxby Farmer Limited and Britannia Engineering Limited are fully exempted from payment of EMD against

tenders of the State Government. Finance Department G.O for waiver of EMD. These Societies/Enterprises, if selected through open tenders will however have to furnish requisite

Security Deposits (SD) for performance of the work. If the selected Societies /Enterprises failure to deposit (SD) within the specified time period, legal action will be charged against the said Societies/Enterprises as per Rule. (if applicable).

- 8. Cost towards Earnest Money Deposit (EMD) must be submitted in the form of Bank Draft (BD) / Bankers Cheque (BC) of any scheduled bank of India in favour of the The Executive Engineer-I, Lower Damodar Irrigation Division, Payable at Singur. Hooghly. Payment in any other form e.g. NSC, KVP, etc. will not be accepted.
 - a) The Tender should quote the rate both in figures and in words on the basis of percentage above below or AT PAR the Schedule of Rates attached with the Tender Form and also in the space provided in the Tender Form.
 - b) Any tender containing over writing is liable to be rejected.
 - c) All corrections are to be attested under the dated signature of the Tenderers.
- 9. When a Tenderers signs his Tender in an Indian Language, the total amount tendered should also be written in the language. In the case of illiterate tender, the rates tendered should be attested by an witness.
- 10. The Tenderers who will sign on behalf of a Company or Firm must produce the registered documents (within 3 days from the date of opening the tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firm under the Indian Partnership Act, failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- 11. Any letter or other instrument submitted separately in modification of the sealed tender may not be entertained.
- 12. Conditional Tender, which does not fulfill any of the above conditions, and is incomplete in any respect, is liable to summary rejection.
- 13. GST, Royalty, Building & other Construction Workers' Cess and all other statutory levy/ Cess etc. will have to be borne by the Contractor (he will have to produce necessary documentary evidence of his having done so at the time of receiving the final payment for the work). It may further be noted that if <u>Valid GST Identification number (GSTIN)</u> document under the relevant GST Acts & Rules of State Govt. is produced before receiving payments per present norms, or as may be prescribed by the Finance Department time to time.

The Tender Accepting Authority does not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received, without assigning any reason whatsoever to the intending tenderers. Additional Performance Security" has been made mandatory which shall be obtained only from the successful L1 bidder, if the accepted bid price is below 20% of tender BOQ or below by more than 20% of the tender BOQ. This Additional Performance Security shall be equal to 10% of the **tendered amount** i.e. 10% of the L1 bid price.

The Additional Performance Security shall have to be submitted by the selected L1 bidder after issuance of Letter of Acceptance / Letter of Invitation (LoA/LoI) within next seven working days and before issuance of Award of Contract (AoC) in the form of "Bank Guarantee" of any Scheduled Bank approved by RBI, payable at Kolkata or / in West Bengal, as per specimen format Form-6. Else, its/their Earnest Money Deposit (EMD) will be forfeited without any prejudice by the Tender inviting authority and the defaulting bidder also debarred from further participation in all future I&WD tenders for a period of one year for committing the offence on the first occasion and for a period of two years for recurrence of the same offence.

The said Bank Guarantee (BG) shall have to be valid up till the end of the contract/Agreement period including extended time period till 100% physical completion of work in all respects and shall be renewed within validity period accordingly if required. The said Bank Guarantee shall remain in custody of the DDO & Executive Engineer in-charge of the work, which shall be returned to the bidder/contractor after successful physical completion of the work as per contract. If the bidder fails to complete the work successfully, this Additional Performance Security shall be forfeited at any time during the pendency of the contract period after serving suitable notice to the contractor/bidder agency. Necessary provisions regarding deduction of security deposit from progressive bills of the contractor in respect of the tendered work shall be governed as per relevant clauses of the tender contract/Agreement which will in no way be affected / altered due to this Additional Performance Security.

- 14. The Tenderers will have to, if so desired by the Tender Accepting Authority, submit his analysis to justify the rate quoted by him.
- 15. The Tenders will be opened, as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives, who may be present at the time of opening and who may also put their signatures in the Tender Opening Register.

- 16. The successful Tenderers will have to execute the quad duplicate copies of his tender which will have to be obtained free of cost in the office of **The Executive Engineer-I**, **Lower Damodar Irrigation Division** within **3 (Three) days** from the date of receipt of the intimation of acceptance of his tender failing which the Earnest Money shall forthwith stand forfeited in favour of the Government and the communication of acceptance of the tender shall automatically stand cancelled.
- 17. If any Tenderers withdraws his tender before its acceptance of refuses/ fails to convert it into a contract within a reasonable time, without giving any satisfactory explanation for such withdrawal/ refusal / failure, he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- 18. The successful Tenderers will have to abide by the provision of the West Bengal Contract Labour (Regulation and Abolition) Rules, 1970 and such other Acts as may be applicable, as will be in force from time to time .
- 19. Materials such as Cement, M.S. Rod. R.C.C. Hume Pipes, Sheet Piles, etc. if available in stock, will be issued by the Department to the Contractor for the work as per issue Rate fixed by the Engineer-in-Charge. Site of issue of materials as mentioned in the list of materials to be supplied Departmentally to the Contractor is furnished with the tender documents for the work. Any other materials not listed, if supplied by the Department, the issue Rate for such material will be fixed by the Engineer-in-Charge.
- 20. Hire charges for Tools & Plants Machinery, if issued departmentally, will be recovered from the Contractor at such rates as will be fixed by the Engineer in-Charge. The period of hire charges of all Tools & Plants Machinery issued from the Government Godown will be counted from the date of their issuance from the Godown and up to the date of return into the same Godown and the hire charges will be recovered from the Contractor accordingly. All Tools & Plants Machinery issued to the Contractor must be returned in good condition. In the case of any damage, the cost of repair to such damage or replacement will be recovered from Contractor.
- 21. In the following cases a tender may be declared informal and unacceptable.
 - a. Correction, alterations, addition etc .if not attested by the Tenderers.
 - b. i. Earnest Money in the form of T.R Challan, D.C.R./ Demand Draft, etc. which are short Deposited and/ or not deposited in favour of <u>The Executive Engineer-I</u>, Lower Damodar Irrigation Division.
 - c. If the Tender Form is not properly filled in respect of the general description of the work, Estimated Cost, Rate of the deduction of Security Deposit etc. in page-2 and other pages as are required to be filled in
 - d. If the specified pages of the Tender Document are not signed by the Tender If the Tender is not submitted in a Cover properly sealed and the name of the work is not indicated on the cover
- 22. To verify the competency, capacity and financial stability of the intending Tenderer(s) the Tender Paper issuing Authority may demand production of any necessary document(s) as it may deem necessary.
- 23. The payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim to delay in payment will be entertained.
- 24. As per G.O.No. 1627(8)/IA dated 26th November 2001 of Irrigation & Waterways Department, Government of West Bengal, Clause 25 of Tender Form No. 2911 stands deleted in respect of contract of value less than Rs. 100.00 lakh.
- 25. Participation in more than one serial of work out of list of works published in one NIT
 - Normally, Tender Paper for not more than one work in any one NIT will be issued to an applicant, who may indicate the Sl. Nos. of the work in the order of priority. However, depending on response to various serials in the N.I.T., Tender Paper Issuing Authority may issue Tender Paper for any serial even though it may not be preferred by the applicant. In other words, technical PQ credential certificate along with relevant documents submitted for any work should at the minimum; satisfy the technical PQ eligibility criteria specified for that work/ works. Normally there should be separate CC along with relevant documents for each of the serial of works, the bidder intends to bid and the serial number relevant to the CC should be clearly written on the body of the CC. However, the bidder will also reserve the right to submit one CC along with relevant documents for bidding in more than one serial of work, **provided cumulative technical PQ credential of all such serials should be fulfilled by one single CC**. In such case also, serial numbers of the relevant works for which the CC is submitted should be clearly written on the body of the CC by the bidder. Omission of serial numbers on the body of the CC in case of bidding for more than one serial will lead to rejection of all the bids.

- 26. Sealed Tender should be dropped in the Tender Box at the office of the **The Superintending Engineer**, **Damodar Irrigation Circle**.
- 27. Payment will be made subject to the availability of fund.
 - a. The Additional Performance Security shall have to be submitted by the selected L1 bidder after issuance of Letter of Acceptance / Letter of Invitation (LoA/LoI) within next seven working days and before issuance of Award of Contract (AoC) in the form of "Bank Guarantee" of any Scheduled Bank approved by RBI, payable at Kolkata or / in West Bengal, as per specimen format Form-6. Else, its/their Earnest Money Deposit (EMD) will be forfeited without any prejudice by the Tender inviting authority
 - b. Power is delegated to TEC to verify the authenticity of bid documents by physically summoning the applicant bidder on the basis of specific doubts which could not be cleared, by the Accounts & estimating branches of the designated Executive Engineer, and reported to the Tender Accepting Authority prior to the issuance of Tender Documents for bidding.
 - c. In case of tie bid Memorandum No-2320-F(Y) Dated:-7th June,2022 of Finance Department, Government of West Bengal shall be applicable

Categorization of Works:

- (i)Type-A Earthwork (relevant to and required for construction / repair / improvement / reconstruction of all types of embankments and land filling or land development: Earthwork in embankments along canals, channels, rivers, reservoirs, earthwork in excavation or desiltation of ponds (exceeding 5 hectares), earthwork for land filling and development (exceeding 10 hectares) and earthwork in road/railway embankments or guide bundhs including items of leads, lifts, disposal and transportation but excluding earthwork in foundation filling or excavation in case of all structures including industrials structures.
- (ii) **Type- B Earthwork** relevant to and required for re-excavation / desiltation / dredging of canals / channels / rivers / barrage ponds): Earthwork in excavation / re-excavation / desiltation / dredging of canals / channels / rivers / seafront / barrage ponds but excluding ponds and lakes, in dry or wet condition, including items of leads, lifts, disposal and transportation.
- Note: Credential for 'Type-B' earthwork may also be considered to ascertain similarly for works including 'Type-A' earthwork but 'vice-versa' cannot be considered. In order of words, bidders having credential of 'Type-A' earthwork will not be eligible for works involving 'Type-B' earthwork''.
- b. **Brickwork/Boulder Masonry Work (other than in Buildings)**: Brickwork/boulder masonry work and cement plaster.
- c. Concrete work (including reinforcement and allied works in case of piling) other than those for buildings: PCC inclusive of shuttering, formwork with staging, RCC of all grades inclusive of all reinforcements & insert plates & formworks shuttering with staging complete & MS liners for bore piles & MS or special alloy sheet piles as cut-off walls or retaining walls in all types of structures, concrete pavement and protection works, but excluding concrete works included under Cl. 7 II (g) below.
- d. **Structural Steel works**: All types of structural steel works including cast iron components but excluding reinforcement rods and all types of MS sheet piles which is included in protection work.
- e. **Protection work**: All types of river/ canal / pond / embankment / road / coastal protection works using PCC / RCC / Bricks / Boulders / Bats / Polythene / Polypropylene / HDPE / Nylon / Jute / geo-jute / Bullah / MS sheet piles / (Enclosure to I&WD No. 344(8)-IB/IW/O/IB-Misc-72/2016-17dated 03.12.2019)

- f. **Road work**: All types of bituminous road / rigid pavement using RCC / PCC / other type of roads using boulder / brickbats / whole bricks / jhama bats / riverbed materials / moorum. In case of construction of PCC pavement upto maximum width of 3.5 m and meant for only 4-wheeler

having Gross Vehicular Weight not exceeding 5.5 MT (maximum Axle Load of 3.5 MT, rates as

- 5R bridge as per IRC-6), PCC/RCC works executed in protection / lining / any other structures including building may also be considered in addition to the criteria stated in the foregoing sentence of this Para.
- g. **Building work**: All items related to brickwork, cement work including PCC and RCC, formworks, staging, shuttering, plastering, carpentry works, painting and flooring, plumbing, electrical connection all finishing items fittings & fixtures except draperies & furniture complete. h. Any other major item or conglomeration of items not mentioned above, namely procurement of goods, equipments, machineries, Tools & Plants, Mechanical, Electrical works, specialised jobs, Fitting, Fixtures etc determined as Major items in respect of the SOR/BoQ of tendered items fulfilling the required criteria.
