As per terms and conditions noted below: -

- 1. The Quotation Papers will be issued free of cost from the office of the undersigned between 11.00 A.M to 5.00 P.M on working day. The willing Bidders must produce valid survey, G.S.T and Registration Certificate, PAN CARD of Income Tax Department and Professional TAX Payment Certificate before issuing Quotation Papers from this Office.
- 2. The Suppliers should Quote his rate in figure and as well as in words in Rupees and Paisa and furnish specification of the Boat in accordance with proforma which will be supplied from the office along with Quotation Papers.
- 3. The copy of Notice of the Quotation which may be obtained along with Schedule and Specification from the Office of the undersigned should accompany the Quotation duly signed by the bidder.
- 4. The acceptance of Quotation will rest with the competent authority, who does not bind himself to accept the lowest Quotation and reserve the right to himself to reject any Quotation without assigning any reason thereof.
- 5. Any canvassing in connection with the Quotation with other bidders is strictly prohibited and Quotation submitted by the supplier resorts to canvassing will be liable for rejection.
- 6. Quotation which should be submitted in sealed cover with the name of work written on the envelop will be received by the undersigned up to 14.00 hours on <u>10/12/2025</u> and will be opened same day after 14.00 Hrs. in presence of Bidders who may be present in this office during the time of opening.
- 7. Quotations which do not fulfill any of the above conditions and in complete in any respect are liable to summarily rejection.

- 8. The Successful Bidders will have to execute the Original and Duplicate Tender in W.B.F No. 2911(ii) with deposit requisite amount of earnest money @ 2.00%(Two Point Zero Zero Percent) in Bank Draft within 7 (Seven) Days from the Date issue of the accepting letter.
- 9. In case of unauthorized withdrawal of the Boat within the contract period the owner of the boat should have no claim for hire charges for the days of absence in addition to this he will be liable to pay compensation as penalty equal to double of hire charges for each days absence or the entire security to be forfeited in favour of the Government.
- 10. If the suppliers fail to supply the boat within a fortnight from the date of acceptance of Quotation the earnest money deposited with Quotation will be forfeited and the Tender must be cancelled by the undersigned without assigning any reason.
- 11. During routine maintenance period of boat, the owner will supply a substitute boat of same facilities as temporary measure only.
- 12. The Government will not liable for any accident/ damaged of the boat during days.
- 13. Certificate for the respective Sub- Divisional Officer in respect of fitness of the boat is to be submitted before issuing of Quotation Papers.

# TERMS AND CONDITION FOR SUPPLYING ENGINEER FITTED COUNTRY BOAT, CUTTER TYPE BOAT AND HOUSE BOAT.

- 1. These should be a separate Cabin, to house; One, Double and 4 fold Chairs. The size of the Cabin Should be 8' X 6' 6" X 4' 0".
- 2. There should be one toilet- cum Urinal convenient to use preferably at the back side.
- 3. The Cabin should be provided with a good looking glass, 2 Nos. hooks and hangers.
- 4. A separate container for storage of drinking water at supplier's cost.
- 5. One separate space for using as kitchen.
- 6. Necessary Cookeries, cutleries and Utensils and detailed in the enclosed Sheet should be supplied including replacing the same in the event of damaged or becoming unserviceable due to constant use.
- 7. Boat should be properly painted and should be fine serviceable condition.
- 8. A drum should be provided for keeping coal.
- 9. Crew consisting of one driver/ dandi/ one hight and two helpers should be supplied to the boat at owner's cost.
- 10. Fuel and Mobil required for running the power operated double cylinder boat will be supplied by the owner himself. The fuel supplied by the owners will be utilized by the Department during official tour. The cost of Diesel and Mobil oil will be paid to the Contractors on production of bills and Cash Memos.
- 11. The boat shall be hired for a period for 1 (one) year from the date of supply without absence any reason.
- 12. The accepting authority also reserves the right to terminate the contract on 7 (Seven) days notice and for which no claim for compensation will be entertained or paid for.
- 13. No compensation will be payable by the Department for want of trip and maintaining the boat in running during the period of contract.
- 14. On accepted on hire by the Department the Boat should be made available at the Jetty as per direction of the accepting authority at their own cost. They will also take the boat back after the termination of the hire period at their own cost.
- 15. If the boat is to be released for repairs during hire period, at boat of identical specification should be placed in lieu of the boat require to be withdrawn for repairs. If no substitute is placed the owner will be liable to pay compensation equal to rate of hire charges for each day absence.
- 16. It will be responsibility of the owner/ supplier to keep the boat neat and tidy failing which they undersigned will be at liberty to rescind the tender.
- 17. If necessary, the boat may have to run both during day and night continuously for which no extra payment would be made them the contracted rate.
- 18. One no. fully equipped "First- Aid Box" should be provided in the boat at the owner's cost including cost of replacement.
- 19. Failing the facilities as mentioned above the undersigned shall have the right to determine the reduce rate of hire charge.
- 20. There should be two bedding with mattresses, pillows, pillow cover, Bed Sheets, bed Covers, mosquito nets etc. for use of the Departmental Officers.
- 21. There should be one tube light and one fan for the cabin for use of the Officers.
- 22. Payment of hire charge, etc. will be paid month wise but the Payment will depend on the availability of Fund.
