NOTICE INVITING TENDER.

 Dte., Bidhannagar, Midnapore on behalf of the Governor of West Bengal, for the Works as per list attached herewith from eligible bonafide outsiders having credential of execution similar nature of work of Value 30% of the amount put to Tender within the last 5 years.
- a. Separate Tender should be submitted for each work as per attached List in Sealed Cover super scribing the name of the work on the envelope and addressed to the proper authority.
 b. Submission of Tender by post is not allowed.
 - **3.**The Tender documents and other relevant particulars (if any) may be seen by the intending Tenderer or by their duly authorized representative during office hours between 11.00 A.M to 5.00 P.M on every working day till 18/12//2025 in the Office of the Executive Engineer, *Kangsabati Canals Division-IV*, I & W. Dte., *Bidhannagar*, *Midnapore*.
- 4 a. <u>IntendingTenders should applyforTender paper sin their respective Letter Heads enclosing self attested copies of the following documents, original of which and documents like Registered Partnership (for Partnership farms)etc. are to be produced on demand, as well as during interview (if any).</u>
 - i. b. Completion Certificate issued by Competent Authority will normally be considered as credential. Completion Certificates (CC) for 100% completed works during the current year and within last five financial years will only be accepted as valid credential.

CC should clearly show the name, postal address, (contact Tel. No. and FAX or e-mail ID if issued outside the jurisdiction of the State) of the office and designation of the officer/ authority issuing the CC for the work along with the name of work and amount put to tender (Tender Value). Illegible certificates and those having incomplete information may be rejected.

CC of works executed in the Irrigation & Waterways Directorate will be considered. CC of works executed in other DepartmentsoftheStateGovernment/organizationsviz.PublicWorks&Public Works(Roads)Department,PublicHealth Engineering Department, Sundarban Affair Department and other State Government Departments, Zilla Parishads & Panchayat Samitiesonlywithinthejurisdiction the State of West Bengal, WBHIDCO, WBSEDCL,WBSETCL, KMDA, KMW & SA,KMC,Other Municipal Authorities and Bodies, HRBC, Engineering Departments of Union Government and Organizations like Farakka Barrage Project(FBP) Authority, Indian Railways, KoPT and companies owned or managed by the Government of West Bengal, i.e. Mackintosh Burn Ltd., Westinghouse SaxbyFarmer Limited & Britannia Engineering Ltd. may also be considered. Such CC are to be issuedby an officer/authority not below the rank of Executive Engineer / Divisional Engineer / District Engineer/Project Manager of the State/Union Government Departments/ Organizations; authorized signatories of CC for Panchayat Samities and Municipalities shall be BDO & Ex-officio Executive Officer and Secretary or equivalent administrative officers respectively. It is desirable to have contact telephone and FAX or e-mail address of the signatory of the CC for all offices outside West Bengal.

Such CC is required to be further countersigned by the immediate superior authority of the issuing authority for all cases other than direct Union Government Departments and Ministries outside the State of West Bengal. Also such certificates when issued in all other States other than those directly of State / Union Government Departments and Indian Railways should contain a declaration that the work has been executed to the satisfaction of the concerned Government Organization and has been declared 100% complete in all respect by the competent authority in the concerned Organization.

c. If a contractor/bidder fails to physically produce the originals of documents (especially the Credential Certificates), orany other bid document on demand by the Tender Evaluation Committee (HTEC/TEC) within a specified time frame, leading to specific doubts which could not be cleared by enquiry from issuing authority of these documents or if there isanysuppression /distortion/falsification noticed/ detected /pointed outatanystage ofthe tender processatanystageprior to signing of Contract-Agreement or the issue of Work Order, the Tender Inviting Authority will immediately bring the matter to the notice of the concerned Chief Engineer and appropriate penal measures as the Government may deem proper will be taken.

Any contractor/bidder may bid for any number of Serials of work in a particular NIT, ifmorethanone work have been published in that NIT subject to fulfillment of the following conditions: Normally there should be separate CC along with relevant documents for each of the serial of

works, the bidder intends to bid and the serial number relevant to the CC should be clearly written on the body of the CC. However, the bidder will also reserve the right to submit one CC along with

relevantdocumentsforbiddinginmorethanoneserialofwork, provided cumulative credential of all such serials

- should be fulfilled by one single CC. In such case also, serial numbers of the relevant works forwhich the CC is submitted should beclearlywrittenonthe bodyofthe CCbythe bidder. Omission of serial numbers on the bodyof the CC, in case of bidding for more than one serial will lead to rejection of all the bids.
- 6. Intending Tenderer not satisfied with the decision of the Tender Paper issuing Authority may prefer an appeal to the next superior Officer. Concerned Chief engineer will be the Appellate Authority for high Value Tenders. Necessary communication regarding his appeal to the Appellate Authority must be brought to the notice of such Authority within two working days after the issue of Tender Paper and copy of such communication should also be submitted to the Tender Paper issuing Authority within the same period failing which no such appeal will be entertained.

Before submitting any Tender the intending Tenderer should make themselves acquainted thoroughlywith the local conditions prevailing by actual inspection of the site and take into considerations all factors and difficulties likely to be involved in the execution of work in all respect including transportation of materials, communication facilities, climate conditions, nature of soil, availability of local laborers and market rate prevailing in the locality etc. as no claim what so ever willbeentertained ontheseaccountsafterwards. In this connection tenderers may contact the office of the undersigned up to 18/12/2025 between 11.00 A.M and 5.00 P.M on any working day.
- 9. Cost towards Earnest Money Deposit (EMD) @ 2 % of the amount put to tender must be submitted in the form of Bank Draft (BD) / Deposit Call Receipt (DCR) of any scheduled bank of India in favour of the Executive Engineer, Kangsabati Canals Division-IV, 1 & W. The Tenderer should quote the rate both in figures and in words on the basis of percentage above / below or At Par the Schedule of Rates attached with the Tender Form and also in the space provided in the Tender Form. The rate should be quoted inone single handwriting and preferably withthe sameink. Ratesquotedin different handwritingshallbe treatedas informal.
 - **b.**Anytendercontainingoverwritingisliabletoberejected;
 - c. All corrections are to be attested under the dated signature of the Tenderer without which tender may be informal.
- **12.** When the Tenderer sign his Tender in an Indian Language, the total amount tendered should also be written in the same Language. In the case of illiterate Tenderer the rates tendered should be attested by an witness.
- 13. The Tenderer who will sign on behalf of a Company or Firm must produce the registered documents (within 3 days from the date of opening the Tender) in support of his competency to enter into an Agreement on behalf of the Company or the Firmunder the Indian Partnership Act. Failing which the Tender will not be considered and the deposited Earnest Money will be forfeited.
- 14. AnyLetterorotherinstrumentsubmittedseparatelyinmodification of these aledtender may not be entertained.
- **15.** The Tenderer should submit a statement at the time of submission of his tender showing the Technical Staff to be maintained for the work, with their technical qualifications, failing which the tender may be liable to rejection.

- **16.** Conditional Tender, which does not fulfill any of the above condition, and is incomplete in any respect, is liable to summarilyrejection.
- 17. In view of introduction of GSTwith effect from 01.7.2017, all the bidders intending to participate in this tender shouldoffertheir bids inclusive of GST applicable for entire composite works / Procurement of goods& services, labour intensive component contained in the BOQ / Schedule of Rate. Income Tax, Royalty, GST (CGST, SGST, IGST), Construction Workers' Welfare Cess, Labour Insurances EPF and similar other statutory levy / cess will have to be borne by the contractor/bidder and his/her quoted rate should be quoted accordingly after considering all these charges, and no separate payment towards any of the statutory taxes rents or levies shall be made by the work implementing authority.
- **18.** The Tender Accepting Authoritydoes not bind himself to accept the lowest tender and reserves the right to reject any or all of the tenders received without assigning any reason whatsoever the intending Tenderers and also reserves the right to distribute the work amongst more than oneTenderers.
- 19. The Tender will have to, if so desired by the Tender Accepting Authority, submithis analysis to justify the rate quoted by him.
- **20.** The Tender will be opened as specified in the list of works, in presence of the participating Tenderers or their duly authorized representatives who may be present at timeof opening and who may also put their signatures in the Tender Opening Register.
- 21. The successful Tenderer will have to execute the duplicate copies of his tender which will have to be obtained in the office of the *Executive Engineer*, *Kangsabati Canals Division-IV*, *I & W. Dte.*, *Bidhannagar*, *Midnapore*, within 7 (Seven) days from the date of receipt of the intimation of acceptance of his tender failing which the Earnest money shall forthwith stand forfeited in favour of the Government and the Communication of acceptance of the tender shall automatically stand cancelled.
- **22.** If any Tenderer withdraws his tender before its acceptance or refuses / fails to convert it into a reason contract within a reasonable time, without giving any satisfactory explanation for such withdrawal/ refusal / failure he shall be disqualified for submitting any Tender in this Division / Circle for a minimum period of one year and his case will be referred to the Government for order as to what further action will be taken against him.
- **23.** The successful Tenderer will have to abide by the provisions of the West Bengal Contract Labour (Regulation and Abolition) Rules, 1972 and such other Acts as may be applicable as will be force from time to time.
- 24. Materials such as Cement M.S. Rod, R.C.C, Hume Pipes, M.S. Sheet Piles etc. if available in stock, will be issued by the Department to the Contractor for the work as per Issue Rate fixed by the Engineer-In-Charge. Site of issue of materials as mentionedinthelist of Materials to be supplied departmentally to the Contractor is furnished with the tender documents for the work. Any other materials not listed therein, if supplied by the Department, the Issue Rate for such materials will be fixed by the Engineer-In-Charge. Otherwise materials will be supplied by the contractor.
- 25. Hire Charge for Tools & Plants Machinery, if Issued Departmentally, will be recovered from the contractor at such rates as will be fixed by the Engineer-In-Charge. The period of hire charges of all Tools & Plants Machinery issued from the Government go down will be counted from the date of their issuance from the go down and upto the date of return into the same go downand the hire charges will be recovered from the Contractor accordingly. All tools & Plants Machinery issued to the Contractor must be returned in good condition. In case of any damage, the cost of repair to such damage or replacement will be recovered from Contractor.

- **27.** For the return of the earnest money of the unsuccessful Tenderer (s) he/they is/are to apply to the **Executive Engineer**, **Kangsabati Canals Division-IV**, **I & W. Dte.**, **Bidhannagar**, **Midnapore**, giving the reference to the work NIT No. date of Tender amount and mode of Earnest Money deposited all in a complete form. The Earnest Money of all Tenders other than lowest Tenderer in each case may be refunded, after acceptance of the rate in the comparative statement, as early as possible.
- **28.** To verify the competent capacity and financial stability of the intending Tenderer(s) the Tender Paper Issuing Authority may demand production of any necessary documents as it may deem necessary.
- **29.** The Payment of R/A as well as Final Bill for any work will be made according to the availability of fund and no claim due to delay in payment will be entrained.
- **30.** Normally Tender Papers will be issued to an applicant who may indicate the Sl. Nos. of the work in the order of priority. However, depending on response to various serials in the NIT Tender Paper Issuing Authority may Issue Tender paper for any serial even though it may not be preferred by the applicant.
- **31.** "Additional Performance Security" has been made mandatory which shall be obtained only from thesuccessful L1 bidder, if the accepted bid price is below 20% of tender Schedule or below by more than 20% of the tender Schedule. This Additional Performance Security shall be equal to 10% of the tendered amount i.e. 10% of the L1 bid price.

The Additional Performance Security shall have to be submitted by the selected L1 bidder <u>afterissuance of Letter ofAcceptance/Letter ofInvitation(LoA/LoI) within next seven workingdays</u> and before issuanceofWorkOrder in the form of "Bank Guarantee" of any Scheduled Bank approved by RBI, payable at Kolkata or / in West Bengal, as per specimen format **Form-6**. Else, its/their Earnest MoneyDeposit(EMD) will be forfeited without any prejudice by the Tender inviting authority.
