Expression of Interest for obtaining competitive budgetary quotes at competitive market prices of different items related to the work "Erosion Abatement in Ganga and Kosi Rivers using Geosynthetic Concrete Mattress or equivalent for Slope Protection and Articulated Concrete Block or equivalent for Toe Protection and Apron at Bhutni Diara under Ratua-I block of Malda district." is being invited by the Executive Engineer, Malda Irrigation Division, Irrigation & Waterways Directorate on behalf of the Governor of West Bengal from reliable, bonafied & resourceful agencies/suppliers/firms/JV-Consortium/bidders having desired credential and financial capability for execution of works similar nature in India or abroad.

This EOI is purely to know the present market rate and under no circumstance it shall be construed as quotation for placing any work order. For competitive bidding separate notice inviting Tender will be published later.

Intending bidder should particularly go through the minimum desired Pre-qualification (PQ) works credential & financial eligibility criteria and satisfy himself/ herself of all the mandatory eligibility requirements. Bidders desirous of participating in the EOI should submit bids only if they fulfill the minimum PQ eligibility criteria and are in possession of all the required PQ Credential documents "in original", Financial proposal (quoted price schedule) of any bidder shall stand valid only if the bidder qualifies the eligibility criteria as laid down in Technical and Financial Pre-Qualification Requirements, detailed below.

Issue of EOI documents:-

Interested Bidders can obtain EOI documents, free of cost, from the Office of the Executive Engineer, Malda Irrigation Division, Irrigation & Waterways Directorate, during office hours on all working days up to 19/12/2025, 3.00 PM or the same may be downloaded from the departmental website www.wbiwd.gov.in.

The intending bidders should submit their EOI for list of items given in format enclosed herewith. Rate for the specified item of work should be filled up properly.

The rate is inclusive of all incidental charges for machinery, manpower, equipment involvement charges, transportation, incidental charges etc. but exclusive of GST & Labour Welfare Cess.

Before submitting EOI, the intending Bidders should make themselves acquainted thoroughly with the existing local labour rate, site condition, work place etc. They may take assistance of this office for such observation, He/ She may contact this office in any working day in between 11.00 A.M. to 3.00 P.M. up to 19/12/2025.

The EOI is required to provide indicative rate of item of work as per schedule attached herewith (**Annexure-I**) in order to have comparison of rates between various prospective bidders and for sanctioning the **lowest** rate from the competent authority of this Department.

Prospective bidders are kindly requested to apply in their letter head enclosed with quoted price schedule.

Prospective bidders are requested to go through the **attachment (Annexure-II)** and **drawing (Annexure-III)** enclosed in this EOI before submitting their rate quote.

Technical and Financial Pre Qualification: Technical Pre Qualification requirements for eligibility of bidders shall be determined from the following documents to be enclosed with quoted price schedule as per attached format in sealed envelope

- 1. Copy of Valid 15-digit Goods and Service Tax payer Identification Number (GSTIN) as per GST Act, 2017.
- 2. Copy of valid Permanent Account Number (PAN) Card.
- 3. Copy of Latest available Professional Tax Payment Certificate (PTPC) or the PT payment challan/ receipt for current financial year/Waiver Order of competent authority in other States if applicable.
- 4. Copy of valid Trade License Certificate

6. It is Desirable that Prospective bidder should have experience of execution in similar type of work, in any Govt. Sector Organization in India within last 5 (five) financial years. Copy of Completion Certificate regarding execution of such work if any issued from Competent Authority not below the rank of Executive Engineer or Executive Officer shall have to be submitted.



ANNEXURE-II (BRIEF REPORT)

The gradual shifting of Ganga River course towards the Fulahar river is taking place at Kataha Diara & Bhutni Diara region in Ratua-I block of Malda district. A study on Satellite Remote Sensing reveals that since 1975 to 1925, the left bank of river Ganga has shifted by 5.864 km at Kataha Diara.



During last 2 years, havoc erosion has also taken place in Bhutni Diara thus engulfing a considerable portion of old Bhutni Diara Circuit Embankment, which was constructed as a spill checking embankment against high flood level of river Ganga during the year 1976-77 in order to protect Bhutni Diara. The paleo channel namely river Koshi has become activated after the flood of 2024, which is now acting as connecting channel between river Ganga and river Fulahar. During the flood of 2025, the newly constructed ring bundh has also been breached and the major cause of this failure is the severe toe erosion as observed near the confluence of river Koshi and river Ganga. The situation has been studied through Satellite Image as presented below.



It has been observed that huge land masses in Bhutni Diara has been lost due to river bank erosion of left bank of river Ganga during the year 2025.

Scope of Present Work

Irrigation & Waterways Department (I&WD), Govt. of West Bengal has executed several anti-erosion and river training works of palliative nature at different parts of Bhutni Diara and Kataha Diara using nylon crated poly bags, nylon crated HDPE bags, boulder revetment and apron, short spur of bamboo porcupine but erosion of river Ganga could not be controlled. The necessity of immediate measures is arising out of considerable changes in the river morphology that have taken place as depicted above.

Considering the gravity of the situation, I&WD has envisaged some erosion abatement works here using Geosynthetic Concrete Mattress or equivalent for Slope Protection and Articulated Concrete Block or equivalent for Toe Protection and Apron for river Ganga and river Koshi. A typical section of protection work has been prepared depending upon the recent hydrographical survey using ADCP and topographical survey using RTK DGPS. An index Map of proposed location of Ratua-I block of Malda district is presented below.




An index Map of proposed work zone is presented below.
